

# SENATE BILL No. 57

January 31, 1989, Introduced by Senator FESSLER and referred to the Committee on State Affairs, Tourism, and Transportation.

A bill to amend section 10 of Act No. 192 of the Public Acts of 1984, entitled  
"Forbes mechanical contractors act,"  
being section 338.980 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 10 of Act No. 192 of the Public Acts of  
2 1984, being section 338.980 of the Michigan Compiled Laws, is  
3 amended to read as follows:

4 Sec. 10. (1) The examination fee for a contractor's license  
5 is \$25.00. The initial fee for the issuance of a contractor's  
6 license is \$25.00.

7 (2) A contractor's license shall expire on December 31 of  
8 each year and shall be renewable within 60 days after that date  
9 upon payment of a fee of \$25.00. After March 1 of each year, all  
10 licenses not renewed shall be void and may be reinstated only

1 upon application for reinstatement and the payment of the  
2 application fee. A person who renews his or her license within 3  
3 years after the license is voided pursuant to this section shall  
4 not be subject to reexamination for the license.

5 (3) BEGINNING JANUARY 1 AND THEREAFTER OF THE YEAR FOLLOWING  
6 THE YEAR OF THE EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED  
7 THIS SUBSECTION, THE DEPARTMENT SHALL NOT RENEW A CONTRACTOR'S  
8 LICENSE UNLESS THE CONTRACTOR OBTAINS NOT LESS THAN 6 HOURS OF  
9 CONTINUING EDUCATION FOR EACH CATEGORY DESCRIBED IN SECTION 6(3)  
10 FOR WHICH THE CONTRACTOR IS LICENSED.

11 (4) THE BOARD, IN CONSULTATION AND WITH THE APPROVAL OF THE  
12 DEPARTMENT, SHALL DETERMINE THE CONTENT OF THE CURRICULUM FOR THE  
13 CONTINUING EDUCATION CLASSES REQUIRED IN SUBSECTION (3) BY THE  
14 PROMULGATION OF RULES PURSUANT TO THE ADMINISTRATIVE PROCEDURES  
15 ACT OF 1969, ACT NO. 306 OF THE PUBLIC ACTS OF 1969, BEING SEC-  
16 TIONS 24.201 TO 24.328 OF THE MICHIGAN COMPILED LAWS.

17 (5) ~~-(3)-~~ All fees and money received by the department for  
18 the licensing of persons under this act, and any other income  
19 which shall be received under this act, shall be paid into the  
20 state construction code fund created by section 22 of the state  
21 construction code act of 1972, Act No. 230 of the Public Acts of  
22 1972, being section 125.1522 of the Michigan Compiled Laws.
