- 1 (3) NOT LATER THAN AUGUST 1, 1989, THE STATE BOARD SHALL
- 2 MAKE AVAILABLE TO SCHOOL DISTRICTS THE GUIDELINES DESCRIBED IN
- 3 SUBSECTION (1) AND SHALL ENCOURAGE THEIR IMPLEMENTATION IN PUBLIC
- 4 SCHOOL CLASSROOMS.
