SENATE BILL No. 103

February 7, 1989, Introduced by Senators V. SMITH and CROPSEY and referred to the Committee on Local Government and Veterans.

A bill to amend the title of Act No. 157 of the Public Acts of 1905, entitled as amended

"An act to authorize a township or townships to acquire by gift or devise real estate and to own and control the same for a public park, resort, bathing beach or other place of recreation; to provide for a board of commissioners therefor and to authorize said township or townships, by a limited tax on the property in such township or townships, to maintain such park or resort and to make rules and regulations for the control and government of the same,"

being sections 41.421 to 41.425 of the Michigan Compiled Laws; to add sections 6, 6a, 6b, 6c, 6d, 6e, 6f, 7, 8, and 9; and to repeal certain acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. The title of Act No. 157 of the Public Acts of
- 2 1905, being sections 41.421 to 41.425 of the Michigan Compiled
- 3 Laws, is amended and sections 6, 6a, 6b, 6c, 6d, 6e, 6f, 7, 8,
- 4 and 9 are added to read as follows:

1 TITLE

An act to -authorize a township or townships to acquire by 2 3 gift or devise real estate and to own and control the same for a 4 public park, resort, bathing beach or other place of recreation; 5 to provide for a board of commissioners therefor and to authorize 6 said township or townships, by a limited tax on the property in 7 such township or townships, to maintain such park or resort and 8 to make rules and regulations for the control and government of 9 the same PROVIDE FOR THE ACQUISITION, MAINTENANCE, MANAGEMENT, 10 AND CONTROL OF TOWNSHIP PARKS, RESORTS, BATHING BEACHES, AND 11 PLACES OF RECREATION; TO PROVIDE FOR THE CREATION OF A TOWNSHIP 12 PARK COMMISSION; TO PROVIDE FOR A BOARD OF COMMISSIONERS TO PRO-13 VIDE FOR THE ISSUANCE OF BONDS AND THE LEVY OF TAXES; TO PROVIDE 14 FOR THE TRANSFER OF CERTAIN REAL PROPERTY FOR PARKS; TO AUTHORIZE 15 CITIES AND VILLAGES TO APPROPRIATE MONEY FOR PARK PURPOSES; TO 16 PROVIDE FOR THE ACQUISITION, CONSTRUCTION, AND USE OF WHARVES, 17 PIERS, DOCKS, AND LANDING PLACES IN TOWNSHIPS; AND TO PROVIDE THE 18 POWERS AND DUTIES OF CERTAIN LOCAL UNITS OF GOVERNMENT AND CER-19 TAIN OFFICIALS. 20 SEC. 6. ON RECEIPT OF A WRITTEN PETITION SIGNED BY NOT LESS 21 THAN 8% OF THE REGISTERED VOTERS OF A TOWNSHIP, THE TOWNSHIP 22 BOARD OF THAT TOWNSHIP, AT ITS FIRST MEETING AFTER THE RECEIPT OF 23 THE PETITION, SHALL SUBMIT THE QUESTION OF ESTABLISHING A TOWN-24 SHIP PARK COMMISSION TO THE REGISTERED VOTERS OF THE TOWNSHIP AT 25 THE NEXT REGULAR ELECTION TO BE HELD IN THE TOWNSHIP. 26 MAJORITY OF THE ELECTORS VOTING ON THE OUESTION VOTE IN FAVOR OF 27 ESTABLISHING A PARK COMMISSION, THE TOWNSHIP BOARD SHALL APPOINT

- 1 A TOWNSHIP PARK COMMISSION OF 6 MEMBERS. THE MEMBERS SHALL SERVE
- 2 UNTIL THE NEXT TOWNSHIP ELECTION AT WHICH TOWNSHIP OFFICERS ARE
- 3 ELECTED. AT THE NEXT TOWNSHIP ELECTION AT WHICH TOWNSHIP OFFI-
- 4 CERS ARE ELECTED, 6 MEMBERS OF THE TOWNSHIP PARK COMMISSION SHALL
- 5 BE ELECTED FOR TERMS OF 4 YEARS EACH.
- 6 SEC. 6A. THE TOWNSHIP PARK COMMISSION SHALL HAVE AUTHORITY
- 7 TO ACQUIRE, MAINTAIN, MANAGE, AND CONTROL TOWNSHIP PARKS AND
- 8 PLACES OF RECREATION, INCLUDING BATHING BEACHES, AND SHALL HAVE
- 9 AUTHORITY, IN THE NAME OF THE TOWNSHIP, TO CONDEMN LAND FOR THOSE
- 10 PURPOSES, IN ACCORDANCE WITH THE CONDEMNATION LAWS OF THIS
- 11 STATE. THE TOWNSHIP BOARD MAY AUTHORIZE THE TOWNSHIP PARK COM-
- 12 MISSION TO ACT AS THE TOWNSHIP RECREATION BOARD PROVIDED BY ACT
- 13 NO. 156 OF THE PUBLIC ACTS OF 1917, BEING SECTIONS 123.51 TO
- 14 123.54 OF THE MICHIGAN COMPILED LAWS. THE TOWNSHIP PARK COMMIS-
- 15 SION MAY ACCEPT, IN THE NAME OF THE TOWNSHIP, GIFTS, GRANTS, AND
- 16 DEVISES OF LAND SUITABLE FOR PARKS AND PLACES OF RECREATION, AND
- 17 GIFTS AND BEQUESTS OF MONEY. THAT MONEY SHALL BE HELD IN TRUST
- 18 AND USED FOR THE ACQUISITION AND IMPROVEMENT OF LAND SUITABLE FOR
- 19 PARKS AND PLACES OF RECREATION.
- 20 SEC. 6B. THE MEMBERS OF THE TOWNSHIP PARK COMMISSION SHALL
- 21 RECEIVE COMPENSATION AS FIXED BY THE TOWNSHIP BOARD. THE TOWN-
- 22 SHIP PARK COMMISSION MAY EMPLOY CLERICAL ASSISTANCE AND INCUR
- 23 OTHER EXPENSES THAT ARE AUTHORIZED BY THE TOWNSHIP BOARD.
- 24 COMPENSATION AND EXPENSES SHALL BE PAID FROM THE PARK MAINTENANCE
- 25 FUND PROVIDED FOR IN SECTION 6C.
- 26 SEC. 6C. THE TOWNSHIP PARK COMMISSION SHALL SUBMIT TO THE
- 27 TOWNSHIP BOARD A DETAILED BUDGET COVERING THE COST OF MAINTENANCE

- 1 OF THE TOWNSHIP PARKS AND PLACES OF RECREATION OF THE TOWNSHIP
- 2 FOR THE ENSUING YEAR. THE BUDGET SHALL NOT EXCEED 1 AND 1/2 MILL
- 3 ON THE ASSESSED VALUATION OF THE TOWNSHIP. THE TOWNSHIP BOARD
- 4 SHALL EXAMINE THE BUDGET AND SHALL APPROVE THE ENTIRE BUDGET, OR
- 5 A PART OF THE BUDGET THAT THE BOARD CONSIDERS REASONABLE AND NEC-
- 6 ESSARY, WHICH SUM SHALL BE INCORPORATED INTO THE TAX ON THE TOWN-
- 7 SHIP, AND WHEN COLLECTED SHALL BE DEPOSITED BY THE TOWNSHIP TREA-
- 8 SURER IN A FUND TO BE KNOWN AS THE PARK MAINTENANCE FUND.
- 9 EXPENDITURES FROM THIS FUND SHALL BE ON VOUCHERS APPROVED BY THE
- 10 TOWNSHIP PARK COMMISSION, AND IT SHALL BE THE DUTY OF THE TOWN-
- 11 SHIP TREASURER TO ALLOW AND PAY THESE VOUCHERS ON PRESENTATION TO
- 12 HIM OR HER. THE ASSESSMENT, LEVY, AND COLLECTION OF THE TAX PRO-
- 13 VIDED IN THIS SECTION SHALL BE PERFORMED IN THE MANNER PROVIDED
- 14 IN THE GENERAL PROPERTY TAX ACT, ACT NO. 206 OF THE PUBLIC ACTS
- 15 OF 1893, BEING SECTIONS 211.1 TO 211.157 OF THE MICHIGAN COMPILED
- 16 LAWS.
- 17 SEC. 6D. THE TOWNSHIP PARK COMMISSION MAY REQUEST THAT THE
- 18 TOWNSHIP BOARD SUBMIT TO THE VOTERS OF THE TOWNSHIP THE QUESTION
- 19 OF THE ISSUANCE OF TOWNSHIP BONDS, THE PROCEEDS OF WHICH SHALL BE
- 20 USED IN THE ACQUISITION OF LANDS FOR TOWNSHIP PARKS AND PLACES OF
- 21 RECREATION. A MAJORITY VOTE OF THE QUALIFIED VOTERS VOTING SHALL
- 22 AUTHORIZE THE ISSUANCE OF TOWNSHIP BONDS. THE ISSUANCE OF TOWN-
- 23 SHIP BONDS SHALL BE GOVERNED BY THE MUNICIPAL FINANCE ACT, ACT
- 24 NO. 202 OF THE PUBLIC ACTS OF 1943, BEING SECTIONS 131.1 TO 139.3
- 25 OF THE MICHIGAN COMPILED LAWS. HOWEVER, IF THE TOWNSHIP HAS NO
- 26 OUTSTANDING INDEBTEDNESS, BONDED OR OTHERWISE, AND THE AMOUNT OF
- 27 THE TOTAL PROPOSED ACQUISITION COST IS LESS THAN ! PER CENT OF

- 1 THE ASSESSED VALUATION OF THE TOWNSHIP, THE TOWNSHIP BOARD MAY
- 2 AUTHORIZE AND DIRECT THE TOWNSHIP PARK COMMISSION TO PURCHASE OR
- 3 CONDEMN DESIGNATED LANDS FOR TOWNSHIP PARKS AND PLACES OF RECRE-
- 4 ATION AND MAY PAY ANNUALLY TO THE TOWNSHIP PARK COMMISSION THE
- 5 AVAILABLE PORTIONS OF CONTINGENT FUNDS OF THE TOWNSHIP NECESSARY
- 6 TO PAY FOR THE ACQUISITION OF THE LANDS. THE TOWNSHIP BOARD
- 7 SHALL DETERMINE THE MAXIMUM AMOUNT TO BE PAID FOR THESE LANDS AND
- 8 IF ACQUISITION IS MADE BY PURCHASE INSTEAD OF CONDEMNATION, SHALL
- 9 ALSO PRESCRIBE THE TERMS OF PAYMENT.
- 10 SEC. 6E. IF LAND IS, OR HAS BEEN, ACQUIRED UNDER THIS ACT
- 11 BY A TOWNSHIP PARK COMMISSION, THE COMMISSION, SUBJECT TO
- 12 APPROVAL OF THE TOWNSHIP BOARD, MAY SELL AND CONVEY THE PORTION
- 13 OR PORTIONS NOT NEEDED ON TERMS THE TOWNSHIP BOARD CONSIDERS
- 14 PROPER.
- 15 SEC. 6F. THE TOWNSHIP PARK COMMISSION SHALL MAKE A DETAILED
- 16 ANNUAL REPORT CONCERNING TOWNSHIP PARKS AND PLACES OF RECREATION
- 17 TO THE TOWNSHIP BOARD AND TO THE STATE TREASURER, IN THE FORM AND
- 18 CONTAINING INFORMATION THAT THE STATE TREASURER DIRECTS.
- 19 SEC. 7. THE TOWNSHIP BOARD OF A TOWNSHIP MAY CONVEY TO THE
- 20 BOARD OF COUNTY PARK TRUSTEES OF A COUNTY IN WHICH THE TOWNSHIP
- 21 IS LOCATED LANDS HELD BY THE TOWNSHIP FOR TOWNSHIP PARKS OR
- 22 PLACES OF RECREATION, INCLUDING LANDS ACQUIRED BY THE TOWNSHIP
- 23 THROUGH THE DEDICATION OF A PLAT DULY APPROVED AND RECORDED, OR
- 24 MAY ARRANGE WITH THE BOARD OF COUNTY PARK TRUSTEES FOR THE
- 25 IMPROVEMENT, MAINTENANCE, MANAGEMENT, AND CONTROL OF THOSE
- 26 LANDS. UPON THE ACCEPTANCE BY THE COUNTY PARK TRUSTEES OF THE
- 27 TRANSFER AND CONVEYANCE, OR UPON THE MAKING OF ANY ARRANGEMENT

- 1 FOR THE CARE, MANAGEMENT, AND CONTROL, THE COUNTY PARK TRUSTEES
- 2 SHALL BE CHARGED WITH ALL THE DUTIES RELATING TO PARKS AND PUBLIC
- 3 PLACES AS ARE PROVIDED BY ACT NO. 90 OF THE PUBLIC ACTS OF 1913,
- 4 BEING SECTIONS 123.61 TO 123.68 OF THE MICHIGAN COMPILED LAWS.
- 5 SEC. 8. THE LEGISLATIVE BODY OF A CITY OR VILLAGE MAY
- 6 APPROPRIATE, OUT OF THE GENERAL OR CONTINGENT FUNDS OF THAT CITY
- 7 OR VILLAGE, FUNDS FOR THE PURPOSE OF CONTRIBUTING TOWARD THE COST
- 8 OF THE ACQUISITION, SUPPORT, MAINTENANCE, UPKEEP, AND IMPROVEMENT
- 9 OF LAND ACQUIRED BY A TOWNSHIP, OR 2 OR MORE TOWNSHIPS, FOR USE
- 10 AS A FREE PUBLIC PARK, RESORT, BATHING BEACH, OR OTHER PLACE OF
- 11 RECREATION. THE CONTRIBUTION SHALL BE MADE TO THE PARK COMMIS-
- 12 SION CREATED BY THE ACT UNDER WHICH THE PARK SITE WAS OR WILL BE
- 13 ACOUIRED.
- 14 SEC. 9. (1) A TOWNSHIP ABUTTING UPON NAVIGABLE WATERS IN
- 15 THIS STATE MAY ACQUIRE, CONSTRUCT, AND MAINTAIN WHARVES, PIERS,
- 16 DOCKS, AND LANDING PLACES FOR THE USE AND BENEFIT OF THE PUBLIC
- 17 AND MAY LEASE AND CONTROL THE WHARVES, PIERS, DOCKS, AND LANDING
- 18 PLACES. THE TOWNSHIP BOARD SHALL ACT FOR THE TOWNSHIP IN ACQUIR-
- 19 ING, CONSTRUCTING, AND MAINTAINING WHARVES, PIERS, DOCKS, AND
- 20 LANDING PLACES IF AUTHORIZED TO DO SO BY THE AFFIRMATIVE VOTE OF
- 21 3/5 OF THE REGISTERED VOTERS OF THE TOWNSHIP VOTING ON THE QUES-
- 22 TION AT A GENERAL OR SPECIAL ELECTION.
- 23 (2) PROCEEDINGS TAKEN UNDER THIS SECTION SHALL BE TAKEN BY
- 24 THE TOWNSHIP BOARD, WHICH HAS THE POWER AND AUTHORITY USUALLY
- 25 EXERCISED BY THE BOARD OF COUNTY ROAD COMMISSIONERS OF THE TOWN-
- 26 SHIP IN ACQUIRING LAND FOR LAYING OUT, CONSTRUCTING, AND
- 27 MAINTAINING HIGHWAYS. THE TOWNSHIP BOARD MAY ACQUIRE LAND FOR

- 1 WHARVES, PIERS, DOCKS, AND LANDING PLACES AND LAY OUT, CONSTRUCT,
- 2 AND MAINTAIN THESE IN ACCORDANCE WITH THE SAME PROCEEDINGS, SO
- 3 FAR AS APPLICABLE, AS ARE REQUIRED TO BE TAKEN BY THE BOARD OF
- 4 COUNTY ROAD COMMISSIONERS OF THE TOWNSHIP FOR ACQUIRING LAND AND
- 5 CONSTRUCTING AND MAINTAINING HIGHWAYS. ACT NO. 283 OF THE PUBLIC
- 6 ACTS OF 1909, BEING SECTIONS 220.1 TO 239.6 OF THE MICHIGAN
- 7 COMPILED LAWS, IS EXTENDED TO INCLUDE WHARVES, PIERS, DOCKS, AND
- 8 LANDING PLACES, SUBJECT TO THE PROVISIONS CONTAINED IN THIS
- 9 SECTION.
