- 6 PROPERTY DISTRIBUTION IN THE EVENT OF THE PARTIES' DIVORCE OR
- 7 LEGAL SEPARATION.

- 1 (2) THE PARTIES MAY ENTER INTO A CONTRACT UNDER THIS SECTION
- 2 PRIOR TO MARRIAGE OR AFTER MARRIAGE IF THE PARTIES ARE
- 3 ANTICIPATING BECOMING DIVORCED.
- 4 (3) A CONTRACT UNDER THIS SECTION IS VOID AND UNENFORCEABLE
- 5 IF EITHER PARTY ENTERED INTO THE AGREEMENT FRAUDULENTLY, UNDER
- 6 DURESS, OR WITHOUT MAKING A FULL AND FAIR DISCLOSURE TO THE OTHER

- 14 BEING SECTIONS 558.1 TO 558.29 OF THE MICHIGAN COMPILED LAWS.
- 15 (B) A WAIVER BY THE PERSON OF ALL RIGHTS TO A HOMESTEAD
- 16 ALLOWANCE, FAMILY ALLOWANCE, ELECTION OR EXEMPT PROPERTY IN THE
- 17 PROPERTY OF THE PERSON'S SPOUSE.
- 18 (C) A WAIVER OF THE RIGHT TO REMAIN IN THE DWELLING HOUSE OF
- 19 A DECEDENT AS PROVIDED IN SECTION 288 OF THE REVISED PROBATE
- 20 CODE, ACT NO. 642 OF THE PUBLIC ACTS OF 1978, BEING SECTION

- 22 (D) A RENUNCIATION BY THE PERSON OF ALL BENEFITS WHICH WOULD
- 23 OTHERWISE PASS TO HIM OR HER FROM THE PERSON'S SPOUSE BY INTES-
- 24 TATE SUCCESSION OR BECAUSE OF THE PROVISIONS OF A WILL EXECUTED
- 25 PRIOR TO THE DATE THE WAIVER WAS EXECUTED.

- (5) A CHANGE OF CIRCUMSTANCES THAT MAKES THE ENFORCEMENT OF
- 2 A CONTRACT ENTERED INTO UNDER THIS SECTION INEQUITABLE MAY BE
- 3 MODIFIED BY THE COURT IN THE COURT'S DISCRETION.
- (6) THE RIGHT OF A CHILD TO SUPPORT SHALL NOT BE ADVERSELY
- 5 AFFECTED BY A CONTRACT ENTERED INTO UNDER THIS SECTION.
