THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Sections 5 and 9 of Act No. 323 of the Public
- 2 Acts of 1976, being sections 317.175 and 317.179 of the Michigan
- 3 Compiled Laws, are amended to read as follows:
- 4 Sec. 5. (1) A prosecution under this act shall be in the
- 5 name of the people of the state, and shall be brought before a
- 6 district court of competent jurisdiction in the county in which
- 7 the offense was committed, and within 1 year from the time the

- 1 (2) In a proceeding for a violation of this act, the
- 2 presence of a person on the enclosed, fenced, or conspicuously
- 3 posted premises of another, or upon any farm lands or farm wood
- 4 lots connected therewith without written consent of the owner,
- 5 his OR HER lessee, or agent shall constitute prima facie evidence
- 6 of unlawful entry.
- 7 (3) A peace officer or conservation officer may SEIZE PROP-
- 8 ERTY AND OTHERWISE enforce this act upon complaint of the land
- 9 owner, his lessee or agent AS PROVIDED IN THIS ACT.
- 10 Sec. 9. (1) A person who violates this act is guilty of a

- 15 SHALL BE PUNISHED BY IMPRISONMENT FOR NOT MORE THAN 90 DAYS, A
- 16 FINE OF NOT LESS THAN \$100.00 OR MORE THAN \$1,000.00, OR BOTH,
- 17 AND THE COSTS OF PROSECUTION.
- 18 (3) IN ADDITION TO THE PENALTIES PROVIDED UNDER SUBSECTIONS

- 27 VIOLATION, INCLUDING, BUT NOT LIMITED TO, FIREARMS, HUNTING

- 1 EQUIPMENT, FISHING EQUIPMENT, SNOWMOBILES, OFF-ROAD VEHICLES,
- 2 TRUCKS, AUTOMOBILES, OR MOTORCYCLES. CONDEMNATION AND CONFISCA-
- 3 TION OF PROPERTY SHALL BE ACCOMPLISHED AS PROVIDED IN ACT NO. 192
- 4 OF THE PUBLIC ACTS OF 1929, BEING SECTIONS 300.11 TO 300.18 OF
- 5 THE MICHIGAN COMPILED LAWS.
