- 6 (ii) Money received by the prisoner from the state as set7 tlement of a claim against the department by the prisoner.
- 8 (iii) A money judgment received by the prisoner from the
 9 state as the result of a civil action in which the department was
 10 a named defendant and found to be liable.
- (iv) Money saved by the prisoner from wages and bonuses paid 12 the prisoner while he or she was confined to a state correctional 13 facility.
- (b) "Cost of care" means the cost to the department of cor15 rections for providing transportation, room, board, clothing,
 16 security, medical, and other normal living expenses of prisoners
 17 under the jurisdiction of the department, as determined by the
 18 -commission of corrections DIRECTOR.
- (c) "Department" means the department of corrections of this
 20 state.

- (e) "Prisoner" means any person who is under the jurisdic-tion of the department and is either confined in any state cor-
- 24 rectional facility or is under the continuing jurisdiction of the 25 department.
- 26 (f) "State correctional facility" means a facility or
 27 institution which houses a prisoner population under the

- 2 includes a correctional camp, community correction center, state
