

# SENATE BILL No. 224

## EXECUTIVE BUDGET BILL

March 7, 1989, Introduced by Senator HOLMES and referred to the Committee on Appropriations.

A bill to make appropriations for the state institutions of higher education and certain state purposes related to education for the fiscal year ending September 30, 1990; to provide for the expenditures of those appropriations: and to prescribe the powers and duties of certain state departments, institutions, agencies, and officers.

### THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1           Sec. 101. There is appropriated for the state institutions of higher  
2 education and certain state purposes related to education, and subject to the  
3 conditions set forth in this act, for the fiscal year ending September 30,  
4 1990, the following respective amounts:

21       Sec. 201. In accordance with the provisions of section 30 of article  
22 IX of the state constitution of 1963, total state spending in this  
23 appropriation act is \$1,148,615,600.00. There are no state appropriations to  
24 be paid to local units of government in section 101.

25       Sec. 202. (1) The sums appropriated in this act shall be paid out of  
26 the state treasury and shall be distributed by the state treasurer to the



1    respective institutions in 12 monthly installments, except for the Martin  
2    Luther King, Jr.-Cesar Chavez-Rosa Parks program which shall receive  
3    distributions in quarterly installments. If the appropriations for the Martin  
4    Luther King, Jr.-Cesar Chavez-Rosa Parks programs are not committed or awarded  
5    by April 1, 1990 the funds shall become subject to legislative transfer. The  
6    amount distributed to an institution shall not exceed the net appropriations  
7    plus additional distributions specifically authorized by this act.

8            (2) Each institution shall receive payments providing the same  
9    percentage increase in its 1989-90 institutional fiscal year over its 1988-89  
10   fiscal year as the percentage increase in state appropriations to each  
11   institution for the state fiscal year 1989-90 over 1988-89, based on the  
12   appropriations and scheduled allotments provided under Acts No. 139 and 201 of  
13   the Public Acts of 1987 and Act No. 325 of the Public Acts of 1988.

14           (3) A detailed description of procedures utilized to arrive at the  
15   amounts appropriated in section 101 shall be submitted to each institution by  
16   the senate and house fiscal agencies.

17           (4) From the amounts appropriated in section 101, institutions shall  
18   reimburse the Michigan public school employees' retirement system at the rate  
19   of 9.0% of retirement members' salaries.

20           Sec. 203. (1) All colleges and universities shall furnish all program  
21   and financial information that is required by and in a manner prescribed by  
22   the state budget director or the house and senate appropriations committees.

23           (2) Pursuant to section 4 of article VIII of the state constitution of  
24   1963, all state institutions of higher education shall furnish an annual  
25   accounting of all income and expenditures to the legislature and the state  
26   budget director.

1           Sec. 204. Money received by the state from the federal government or  
2 private sources for the use of a college or university is appropriated for the  
3 purpose for which provided. The acceptance and use of federal or private  
4 funds shall not place an obligation upon the legislature to continue the  
5 purposes for which the funds are made available.

6           Sec. 205. The appropriations contained in this act shall not be used  
7 for the construction of buildings or operations of institutions of higher  
8 education not expressly authorized in section 101.

9           Sec. 206. The appropriations in this act are subject to section 391  
10 of the management and budget act, Act No. 431 of the Public Acts of 1984,  
11 being section 18.1391 of the Michigan Compiled Laws.

12           Sec. 207. Each institution that is appropriated funds under this act  
13 shall comply with requests for data made by the Michigan postsecondary  
14 education database policy council.

15           Sec. 208. The appropriations contained in this act shall not be  
16 expended for renting, purchasing, or showing any movie film determined to be  
17 obscene pursuant to Miller v California, 413 U.S. 15 (1973).

18 GRANTS AND FINANCIAL AID

19           Sec. 301. Payments of the amounts included in section 101 for the  
20 state competitive scholarship program shall be made as follows:

21           (a) \$1,200.00 maximum per award in accordance with section 3(1) of Act  
22 No. 208 of the Public Acts of 1964, being section 390.973 of the Michigan  
23 Compiled Laws.

24           (b) \$25,878,800.00 total state general fund.

25           Sec. 302. (1) The amounts appropriated in section 101 for the state

1 tuition grant program shall not exceed the following:

2 (a) \$2,475.00 maximum per grant.

3 (b) \$45,899,400.00 total state general fund.

4 (2) Tuition grant awards shall be made to all eligible Michigan  
5 residents who apply before September 1, 1989, and who are qualified. If  
6 funding remains, eligible applicants who apply after September 1, 1989, shall  
7 be granted awards until funding is exhausted.

8 Sec. 303. Included in the appropriation in section 101 is funding for  
9 the Michigan work study program. Of the amount appropriated for the Michigan  
10 work study program, at least \$430,500.00 shall be allocated for graduate work  
11 study. An effort should be made by each institution participating in the  
12 Michigan work study program to assure that not less than 10% of those  
13 undergraduate, graduate, and professional students eligible to participate in  
14 the program are placed with for-profit employers. The authority shall submit  
15 a report to the clerk of the house and the secretary of the senate no later  
16 than March 31, 1990, specifying the level of participation by each institution.

17 Sec. 304. (1) Payments of the amounts included in section 101 for the  
18 general degree reimbursement program shall be made as follows:

19 (a) The reimbursement rate per eligible degree shall be the equally  
20 prorated amount permitted by the appropriation, except that the amount of the  
21 reimbursement for each associate degree shall be 1/2 of the rate of  
22 reimbursement for each bachelor or master degree.

23 (b) Total general degree reimbursement payments shall not exceed  
24 \$4,100,200.00.

25 (c) From the general degree reimbursement program, \$135,300.00 shall  
26 be provided to Spring Arbor college for the southern Michigan state prison

1 program.

2 (d) From the general degree reimbursement program, \$200,500.00 shall  
3 be provided to the university of Detroit for graduate research aid.

4 (e) From the general degree reimbursement program, \$30,100.00 shall be  
5 provided to Marygrove college for learning clinics.

6 Sec. 305. Payments of the amounts included in section 101 for the  
7 allied health degree reimbursement program shall be made as follows:

8 (a) The reimbursement rate per eligible degree shall be the equally  
9 prorated amount permitted by the appropriation.

10 (b) Total allied health degree reimbursement payments shall not exceed  
11 \$627,500.00.

12 Sec. 306. (1) Funds disbursed through the degree reimbursement  
13 programs shall not be used by any recipient institution for theology or  
14 divinity programs.

15 (2) Each eligible institution shall be provided on October 1, 1989, or  
16 as soon as possible thereafter, a preliminary payment of at least 75%, but not  
17 more than 90%, of its estimated degree reimbursements under section 101. The  
18 balance of the degree reimbursement to each eligible institution shall be  
19 provided when the numbers of earned degrees conferred and total amounts to be  
20 paid are certified.

21 Sec. 307. The funds for the American Indian tuition waiver  
22 reimbursement in section 101 are to reimburse tuition waivers granted by  
23 colleges before September 30, 1988. Only those expenses classified as tuition  
24 assessments are eligible for reimbursement.

25 Sec. 308. Included in the appropriations in section 101 for higher  
26 education are \$500,000.00 for the establishment of the Robert C. Byrd honors

1 scholarship program. Pursuant to the implementation of this program, the  
2 legislature encourages the department of education to distribute funds for  
3 this scholarship program to each high school in this state and to allow each  
4 high school to select a merit scholar.

5       Sec. 309. To enable the legislature to evaluate the appropriation  
6 needs of institutions of higher education, each independent college and  
7 university shall make available to the legislature, upon request, data  
8 regarding grants for the preceding, current, and ensuing fiscal years.

9       Sec. 310. The auditor general shall audit selected enrollments,  
10 degrees, and awards at selected independent colleges and universities  
11 receiving awards administered by the department of education. The audits  
12 shall be based upon definitions and requirements established by the department  
13 of management and budget and the senate and house fiscal agencies. The  
14 auditor general shall submit a report of findings to the senate and house  
15 appropriations committees not later than May 1, 1990.

16 STATE UNIVERSITIES

17       Sec. 401. The legislature encourages the development of an  
18 educational reciprocity program between Lake Superior state university and the  
19 colleges of northern Ontario.

20       Sec. 402. Student health services at state universities shall be  
21 self-supporting through student and user fees.

22       Sec. 403. (1) The auditor general shall audit enrollments at all  
23 public baccalaureate institutions of higher education. The audits shall be  
24 based upon the definitions and requirements established by the department of  
25 management and budget and the senate and house fiscal agencies. The audits  
26 shall be based on uniform reporting categories and shall include HEIDI data.

1 The auditor general shall submit a report of findings to the senate and house  
2 appropriations committees no later than March 1, 1990.

3 (2) Student credit hours reports shall not include the following:

4 (a) Student credit hours generated through correspondence courses,  
5 credit by examination, or inmate prison programs regardless of teaching  
6 location.

7 (b) Student credit hours generated in new degree programs after  
8 January 1, 1975, that have not been specifically authorized for funding by the  
9 legislature, except spin-off programs converted from existing core programs  
10 that do all of the following:

11 (i) Represent new options, fields, or concentrations within existing  
12 programs.

13 (ii) Are consistent with the current institutional role and mission.

14 (iii) Are accommodated within the continuing funding base of the  
15 institution.

16 (iv) Do not require a new degree level beyond that which the  
17 institution is currently authorized to grant within that discipline or field.

18 (v) Do not require special grant funding from the state. As used in  
19 this subparagraph, "special grant funding" means funding in addition to that  
20 provided by the student credit hours generated within the program, either  
21 before program initiation or within the first 3 years of program operation.

22 Sec. 404. Included in the amounts appropriated in section 101, there  
23 is appropriated to Wayne state university the sum of \$440,000.00 for  
24 cooperative leadership skills programs for trade union minorities and women.  
25 This program is to be offered by a consortium consisting of eastern Michigan  
26 university, Michigan state university, northern Michigan university, Oakland

1 university, university of Michigan, and Wayne state university. Wayne state  
2 university shall act as fiscal agent, and the funds shall be divided among the  
3 participating universities.

4 Sec. 405. Included in the amounts appropriated in section 101 are  
5 funds for the following consortia projects:

6 (a) Northern inter-collegiate research sharing consortium central  
7 Michigan university and Kirtland community college.

8 (b) Manufacturing technology and management consortium Grand Valley  
9 state university, Ferris state university, and Grand Rapids junior college.

10 (c) Industrial development institute Michigan state university and  
11 Lansing community college.

12 (d) Enabling technology consortium university of Michigan, Michigan  
13 state university, and Wayne state university.

14 (e) Kalamazoo consortium western Michigan university, Kalamazoo valley  
15 community college, Kalamazoo college, and Nazareth college.

16 Sec. 406. The principal executive officer of each institution of  
17 higher education receiving an appropriation under this act shall expend a  
18 portion of the funds appropriated to the institution in reporting to the house  
19 and senate appropriations committees, the auditor general, the senate and  
20 house fiscal agencies, and the department of management and budget within 60  
21 days after the auditor general issues his or her annual report on the  
22 operation of the institution. The institution's report shall specify all of  
23 the following:

24 (a) The recommendations of the auditor general implemented by the  
25 institution, including projected dates and resources required, if any, to  
26 achieve compliance.

1           (b) The recommendations of the auditor general not implemented by the  
2 institution or implemented by the institution as modified.

3           (c) The rationale for not implementing a recommendation of the auditor  
4 general or of implementing a recommendation as modified.

5           Sec. 407. From the funds appropriated in section 101 for Michigan  
6 state university cooperative extension service, the legislature encourages  
7 that \$250,000.00 be expended for the expanded food and nutrition education  
8 program.

9           Sec. 408. From the amount appropriated in section 101 for state  
10 universities, \$30,000.00 shall be expended to establish a systematic method  
11 for universities to inform school districts regarding the number of students  
12 from their districts who are enrolled in remedial/developmental course work.  
13 The presidents council of state universities shall submit a report, not later  
14 than January 31, 1990, to the chairs of the house and senate appropriations  
15 committees concerning the progress made in establishing the reporting system  
16 described in this section. Each university shall allocate \$2,000.00 of the  
17 funds appropriated to their institution in section 101 to promote  
18 communication between school district personnel and university personnel so  
19 that a cooperative effort can be made to improve student academic preparation.

20           Sec. 409. To encourage more students to study mathematics in high  
21 school and to reduce the amount of remediation in the mathematics area at the  
22 college and university level, \$160,500.00 is appropriated in section 101 for  
23 the Michigan mathematics early placement test. Included within the  
24 appropriation in section 101 for each state university is \$10,700.00 for the  
25 implementation of the mathematics early placement test program which was  
26 proposed by the presidents council of state universities. A report on the



1 results of the mathematics early placement test program shall be submitted by  
2 the presidents council to the house and senate appropriations committees by  
3 June 1, 1990.

4 Sec. 410. (1) Included in the appropriation for each Michigan public  
5 university from the amount in section 101 is funding for the Martin Luther  
6 King, Jr.-Cesar Chavez-Rosa Parks visiting professors program.

7 (2) Universities with student head count totals exceeding 20,000 for  
8 the fall of 1988 are appropriated \$84,600.00 each. Universities with student  
9 head count totals of less than 20,000 for the fall of 1988 are appropriated  
10 \$21,100.00 each.

11 (3) Martin Luther King, Jr.-Cesar Chavez-Rosa Parks visiting  
12 professors program funds shall be expended to increase the number of minority  
13 instructors in the classroom and provide role models for underrepresented  
14 minority students.

15 (4) The presidents council of state universities shall report by  
16 October 30, 1989 to the house and senate appropriations committees, the office  
17 of minority equity in postsecondary education, and the department of  
18 management and budget all of the following Martin Luther King, Jr.-Cesar  
19 Chavez-Rosa Parks visiting professors program information:

20 (a) Names of visiting professors.

21 (b) Courses instructed by visiting professors.

22 (c) Duration and dates of instruction.

23 (d) Employment status, excluding Martin Luther King, Jr.-Cesar  
24 Chavez-Rosa Parks visiting professor duties.

25 (e) Race and sex of visiting professors.

26 (5) Martin Luther King, Jr.-Cesar Chavez-Rosa Parks visiting professor

1 funds shall be equally matched with institution funding devoted to the purpose  
2 stated in subsection (3). No part of the visiting professor funds or the  
3 institution's matching funds shall be deducted to cover indirect costs.

4       Sec. 411. (1) Included in the appropriation for each public  
5 university in this state from the amount appropriated in section 101 is  
6 funding for a Martin Luther King, Jr.-Cesar Chavez-Rosa Parks  
7 fellowship/scholarship program. The Martin Luther King, Jr.-Cesar Chavez-Rosa  
8 Parks fellowship/scholarship program is intended to increase the pool of  
9 minority candidates pursuing academic careers in postsecondary education in  
10 this state.

11       (2) The Martin Luther King, Jr.-Cesar Chavez-Rosa Parks  
12 fellowship/scholarship program shall be administered by each institution.  
13 Each institution may grant a scholarship or fellowship to a student to attend  
14 any Michigan university. An award shall be granted to a candidate considered  
15 by the granting institution to be an underrepresented minority in that  
16 academic field of study. University of Michigan-Ann Arbor, Michigan state  
17 university, Wayne state university, and western Michigan university may grant  
18 only fellowships under this program.

19       (3) A Martin Luther King, Jr.-Cesar Chavez-Rosa Parks fellowship shall  
20 be awarded to a candidate who will:

21       (a) Begin an academic career in a Michigan postsecondary educational  
22 institution within 1 year after attaining his or her doctorate degree.

23       (b) Remain in an academic career in Michigan postsecondary education  
24 for a period of not less than 3 years.

25       (c) Pursue a doctorate at a Michigan postsecondary educational  
26 institution.

1           (4) A Martin Luther King, Jr.-Cesar Chavez-Rosa Parks scholarship  
2 shall be awarded to a candidate who is pursuing a doctorate degree at a  
3 Michigan postsecondary educational institution within 1 year after attaining  
4 his or her masters degree.

5           (5) A Martin Luther King, Jr.-Cesar Chavez-Rosa Parks  
6 fellowship/scholarship is intended to offset any educational or living  
7 expenses that the fellow or scholar may incur, so long as the student remains  
8 in good academic standing as defined by the host institution.

9           (6) A Martin Luther King, Jr.-Cesar Chavez-Rosa Parks fellowship award  
10 shall not exceed \$25,000.00 for a student pursuing a doctorate degree, and  
11 shall not exceed \$15,000.00 for a student pursuing a masters degree. A  
12 fellowship/scholarship candidate shall not receive more than 1 Martin Luther  
13 King, Jr.-Cesar Chavez-Rosa Parks fellowship/scholarship award in order to  
14 pursue the same degree or a degree at that same level of study. Martin Luther  
15 King, Jr.-Cesar Chavez-Rosa Parks scholarship recipients are to be considered  
16 candidates for the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks fellowship  
17 program, when eligible.

18           (7) A Martin Luther King, Jr.-Cesar Chavez-Rosa Parks fellow has 4  
19 years in which to attain his or her doctorate degree. This 4-year period  
20 begins after obtaining a masters degree or spending an equivalent 2-1/2 year  
21 period at masters level studies. A Martin Luther King, Jr.-Cesar Chavez-Rosa  
22 Parks scholar shall attain the masters degree within 2-1/2 years of receiving  
23 the award. The Michigan higher education assistance authority may extend  
24 these periods by 1 year for good cause.

25           (8) The Martin Luther King, Jr.-Cesar Chavez-Rosa Parks  
26 fellowship/scholarship shall be defaulted and considered a loan subject to

1    repayment in full to the state if any 1 of the following occurs:

2            (a) The recipient fails to maintain good academic standing at the  
3    postsecondary institution.

4            (b) The recipient fails to attain the appropriate degree in the time  
5    required by subsection (7).

6            (c) The recipient fellow does not meet the requirements of subsection  
7    (3)(a) and (b), or the recipient scholar does not meet the requirements of  
8    subsection (4).

9            (9) The first fellowship/scholarship repayment is due within 1 year of  
10   fellowship/scholarship default, as described in subsection (7). The loan  
11   amount to be repaid shall include the fellowship/scholarship award, plus  
12   interest calculated at a rate not less than that of the guaranteed student  
13   loan at the time of default, and collection fees including attorney fees,  
14   according to a schedule established by the Michigan higher education  
15   assistance authority. Interest amounts shall be calculated pursuant to the  
16   interest computation procedures of the guaranteed student loan program.  
17   Repayment shall be made according to a schedule published by the Michigan  
18   higher education assistance authority. The schedule shall call for repayment  
19   of the loan within a period of not more than 10 years, or monthly repayment of  
20   \$100.00, whichever is less.

21            (10) Each university granting Martin Luther King, Jr.-Cesar  
22   Chavez-Rosa Parks awards shall require recipients to sign an agreement  
23   specifying acceptance of the terms of the award.

24            (11) The Michigan higher education assistance authority shall  
25   implement and administer the loan repayment provisions of subsections (8) and  
26   (9).

1 (12) The Michigan higher education assistance authority shall report  
2 by September 30, 1990, and each year thereafter, on September 30, to the house  
3 and senate appropriations committees and the office of minority equity in  
4 postsecondary education all of the following information:

5 (a) Names of student fellows/scholars, the institutions, and fields of  
6 study.

7 (b) Names of scholars having completed their masters degree  
8 requirements and their current educational status.

9 (c) Names of fellows having completed their studies, and their current  
10 employment status or employing institutions, or both.

11 (d) Names of fellows/scholars in default as described in subsection  
12 (8), and the status of their Martin Luther King, Jr.-Cesar Chavez-Rosa Parks  
13 fellowship/scholarship repayment.

14 (13) Martin Luther King, Jr.-Cesar Chavez-Rosa Parks  
15 fellowship/scholarship funds shall not supplant institutional funding devoted  
16 to the purpose stated in subsection (1).

17 (14) On April 15, 1990, each university shall report to the office of  
18 minority equity, the name and social security number of each recipient of a  
19 Martin Luther King, Jr.-Cesar Chavez-Rosa Parks scholarship or fellowship, and  
20 the amount, date, and duration of the award.

21 (15) If any funds are not awarded or committed by a university to a  
22 specific recipient by April 1, 1990, the department of management and budget  
23 may recommend legislative transfers to other Martin Luther King, Jr.-Cesar  
24 Chavez-Rosa Parks line items within a university or to Martin Luther King,  
25 Jr.-Cesar Chavez-Rosa Parks line items at another university.

26 Sec. 412. (1) Included in section 101 is funding for the Martin  
02147'89

1 Luther King, Jr.-Cesar Chavez-Rosa Parks college day program. The Martin  
2 Luther King, Jr.-Cesar Chavez-Rosa Parks college day program is an  
3 intervention program intended to introduce school children underrepresented in  
4 postsecondary education to the potential of a college education.

5 (2) The programs shall provide a day, overnight, or extended  
6 experience on the college campus for pupils in grades 7 through 11, if the  
7 program meets the intent stated in subsection (1), and is designed primarily  
8 as a motivational program to inspire targeted pupils to pursue a college  
9 education. It is not designed principally as an academic or athletic skills  
10 development program.

11 (3) If possible and practical, the program shall focus on serving  
12 those 35 school districts with the highest percentage of minority pupils as  
13 reported to the Michigan department of education. However, all eligible  
14 pupils from the participating school districts shall be included in this  
15 program, regardless of the pupil's race.

16 (4) Each pupil participating in the program shall be provided with  
17 standard appropriate background information describing the Michigan  
18 postsecondary education system, both 2-year and 4-year public and independent  
19 degree granting colleges and universities, the opportunities afforded by a  
20 college experience, admissions requirements, and financial aid availability.  
21 The Michigan department of education shall develop and make available this  
22 material.

23 (5) Individual program plans shall include all of the following:

24 (a) A budget of equal contributions from this program, the  
25 participating public university, the participating school district, and the  
26 participating independent degree granting college. No college day funds may

1 be deducted to cover indirect costs. No more than 20% of the university match  
2 may be attributable to indirect costs.

3 (b) A letter of support signed by the superintendents of the  
4 participating school districts and the presidents or chancellors of the  
5 participating colleges and universities named in subsection (5)(a).

6 (c) The formal involvement of the appropriate public 2-year colleges  
7 and independent degree granting colleges in the college day program.

8 (6) The presidents council of state universities shall report by  
9 September 30, 1990, and each year thereafter, to the house and senate fiscal  
10 agencies, the office of minority equity in postsecondary education, and the  
11 department of management and budget all of the following for each  
12 participating university and school district:

13 (a) Number of pupils participating and their schools.

14 (b) Age, race, and sex of participating pupils.

15 (c) Description of the college experience offered by the program to  
16 the pupils.

17 (d) A copy of the program plans described in subsection (5).

18 (e) A copy of the program budget.

19 (7) The participating school district, the participating colleges and  
20 universities, and the presidents council of state universities shall retain  
21 the information as is necessary to assess the long-range impact of the Martin  
22 Luther King, Jr.-Cesar Chavez-Rosa Parks college day program on the high  
23 school graduation rate, college attendance of participating pupils, or any  
24 other benefits that may be realized by this program.

25 (8) The universities shall submit a report to the office of minority  
26 equity by January 30, 1990, detailing their plans for college day activities

1 for the 1990-91 fiscal year.

2           Sec. 413. (1) The teaching excellence fund appropriated in section  
3 101 is created to recognize outstanding teaching performance by faculty  
4 members of state universities.

5           (2) An award of \$10,000 shall be made to faculty members selected by a  
6 process administered by each university which provides for participation by  
7 students and members of the faculty. All faculty members in the tenure track  
8 of a university shall be eligible for selection for an award.

9           (3) The criteria to be used in the selection process are to be limited  
10 to the following: superior classroom performance, innovative instructional  
11 practice, high educational standards and concern for students in and out of  
12 the classroom.

13           (4) By May 1, 1990 each university receiving teaching excellence funds  
14 shall report to the legislature and the department of management and budget  
15 the following: the names of faculty members receiving teaching excellence  
16 fund awards, the basis for each award and description of the selection process.

17           (5) Each institution shall receive a number of awards based on the  
18 number of full-time faculty as follows:

19           One award each: Lake Superior state university, Saginaw Valley state  
20 university, university of Michigan at Flint, University of Michigan at  
21 Dearborn and Grand Valley state university.

22           Two awards each: Michigan technological university, northern Michigan  
23 university and Oakland university.

24           Three awards each: Ferris state university and central Michigan  
25 university.

26           Four awards each: eastern Michigan university and western Michigan



1 university.

2 Six awards: Wayne state university.

3 Nine awards: university of Michigan at Ann Arbor.

4 Ten awards: Michigan state university.

5 Sec. 414. Included in the amounts contained in section 101, Wayne  
6 state university is granted \$320,000.00 for the college of education to  
7 deliver professional school district programs to meet their service needs. A  
8 minimum of \$100,000.00 shall be allocated for the establishment and  
9 maintenance of a staff development/school improvement program with the  
10 intermediate school district servicing its area.

11 Sec. 415. (1) Included in the amounts contained in section 101,  
12 Oakland university is granted \$220,000.00 for the labor education service  
13 program.

14 (2) Included in the amounts contained in section 101, Oakland  
15 university is granted \$25,000.00 for community services of Oakland.

16 Sec. 416. The legislature recognizes the value of cooperative  
17 programs between state universities and community colleges aimed at  
18 stimulating economic development and diversification in this state. It is the  
19 intent of the legislature to encourage continued development and expansion of  
20 these cooperative programs in the years ahead.

21 Sec. 417. It is the intent of the legislature that eastern Michigan  
22 university shall coordinate a professional teacher development program for  
23 local area school districts.

24 Sec. 418. (1) From the amount appropriated in section 101 for select  
25 student support services programs, \$1,545,000.00 is allocated for developing  
26 academically and economically disadvantaged student retention programs for

1 4-year public and independent educational institutions in this state.

2 (2) Not later than January 1, 1990, the office of minority equity in  
3 postsecondary education shall develop and make available proposal guidelines  
4 to eligible 4-year institutions. Each proposal shall be submitted to the  
5 office not later than February 15, 1990.

6 (3) A committee shall be established to review submitted proposals and  
7 to make recommendations. The committee shall be composed of 1 member  
8 appointed by the office of minority equity in postsecondary education, 1  
9 member appointed by the association of independent colleges and universities  
10 of Michigan, and 3 members appointed by the presidents council of state  
11 universities.

12 (4) A 3-member review panel composed of 1 member appointed by the  
13 speaker of the house of representatives, 1 member appointed by the majority  
14 leader of the senate, and 1 member appointed by the state budget director  
15 shall review all committee recommendations and make awards.

16 (5) The review panel shall make its awards to eligible institutions  
17 not later than April 1, 1990. An award to any 1 institution shall not be  
18 greater than \$150,000.00, and the amount awarded shall be matched on an 80%  
19 state, 20% college-university basis.

20 (6) An educational institution that receives an award under this  
21 section shall report by September 30, 1990 to the house and senate  
22 appropriations committees, the office of minority equity in postsecondary  
23 education, and the department of management and budget all of the following  
24 information:

25 (a) A description of select student support services programs  
26 initiated.

1 (b) The number of participants, measured in head count, by racial,  
2 ethnic, and 4-S program category.

3 (c) Other information considered necessary or appropriate by the  
4 office of minority equity in postsecondary education.

5 (7) The funds awarded under this section shall not supplant  
6 institutional funding devoted to the purpose described in subsection (1).

7 Sec. 419. It is the intent of the legislature in expending funds for  
8 the operation of the D.J. Jacobetti vocational skill center that the following  
9 activities be performed in order to insure that the integrity and the original  
10 role set forth for the vocational skill center be retained:

11 (a) Insuring the flexibility and adequate autonomy that will enable  
12 the vocational skill center to expand, upgrade, and modify its existing  
13 programs as well as to develop new vocational programs in partnership with its  
14 industrial, commercial, agency, and labor advisories. The length and content  
15 of programs at the skill center, whether they be certificate, 1-year, or  
16 2-year, shall be determined by the performances required in the marketplace  
17 rather than by baccalaureate criteria.

18 (b) Developing a ladder of articulation at northern Michigan  
19 university that grants fair value for vocational skill center credits that  
20 constitute a viable portion of a related 2-year or 4-year baccalaureate career  
21 ladder. This articulation process shall be accomplished without nullifying  
22 the intent of the vocational program or consuming those programs into the  
23 baccalaureate department.

24 (c) Funding the skill center for its credit hour production in a  
25 manner equitable to other vocational technical centers.

26 (d) Placing the vocational skill center budget funds and the decision

1 making process for housing certificate and 1-year or 2-year vocational  
2 technical programs within the vocational skill center under the direct  
3 supervision of the vocational skill center administration in order to insure  
4 the integrity and the continuation of the role of the skill center.

5       Sec. 420. Each state university shall submit an annual report in a  
6 manner prescribed by the department of management and budget describing each  
7 energy conservation project financed wholly or in part by oil overcharge  
8 revenues appropriated in fiscal year 1987 and fiscal year 1988. The report  
9 shall include a description of each energy conservation project and the actual  
10 expenditures and energy savings estimates. The information contained in the  
11 report shall be utilized to meet the annual reporting requirements to the  
12 United States district court and the United States secretary of energy  
13 regarding state use of oil overcharge refunds.

14       Sec. 421. From the amounts appropriated in section 101 for operations  
15 for each public institution, at least 1.5% shall be expended for physical  
16 plant maintenance. Each university shall submit a report delineating their  
17 1988-89 plant maintenance expenditures to the senate and house appropriations  
18 subcommittees on higher education not later than January 1, 1990.

19       Sec. 422. The university of Michigan biological station at Douglas  
20 lake in Cheboygan county is regarded as a unique resource and is designated as  
21 a special research reserve. It is the intent of the legislature to protect  
22 and preserve the unique long-term research value and capabilities of the  
23 biological station area and Douglas lake. The legislature further intends  
24 that no state programs or policies be developed which would have a deleterious  
25 impact on the research value of Douglas lake.

26       Sec. 423. (1) Included in section 101 is funding for a linkage

1 program between public 4-year universities and public community colleges. The  
2 purpose of this program is to increase the number of underrepresented minority  
3 students who transfer from community colleges into baccalaureate programs.

4 (2) The grants shall be made under this program to Michigan public  
5 universities. The grants shall reflect geographic diversity.

6 (3) Not later than October 1, 1989, the office of minority equity in  
7 postsecondary education shall develop and make available proposal guidelines  
8 to eligible universities. Each proposal shall be submitted to the office not  
9 later than October 30, 1989.

10 (4) The office of minority equity shall review submitted proposals and  
11 make recommendations to the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks  
12 review panel established in section 419.

13 (5) The review panel shall review the recommendations of the office of  
14 minority equity and make awards not later than November 15, 1989. An award to  
15 any 1 institution shall not be greater than \$150,000.00, and the amount  
16 awarded shall be matched on an 80% state, 20% university basis.

17 (6) An educational institution that receives an award under this  
18 section shall report by September 30, 1990, to the house and senate  
19 appropriations committees, the department of management and budget, and the  
20 office of minority equity in the manner requested by the office of minority  
21 equity on the progress made to increase the number of minority students  
22 transferring from the community college into baccalaureate degree programs.

23 (7) The funds awarded under this section shall not supplant  
24 institutional funding devoted to the purpose described in subsection (1).

25 Sec. 424. Included in the appropriation in section 101 for the Martin  
26 Luther King, Jr.-Cesar Chavez-Rosa Parks program is \$136,000.00 for a media

1 presentation program. From this amount, the office of minority equity, in  
2 collaboration with the American association of university professors, shall  
3 develop media presentations to motivate minority students to enter higher  
4 education and to instruct minority students and their families in college and  
5 financial aid opportunities.

6       Sec. 425. From the funds appropriated in section 101, \$242,000.00  
7 shall be allocated to northern Michigan university in collaboration with the  
8 Upper Peninsula development institute for the development of an Upper  
9 Peninsula-wide telecommunications plan and for reimbursement of northern  
10 Michigan university's costs related to the project. Objectives for the  
11 telecommunications plan shall include, but not be limited to, providing 2-way  
12 interactive video, audio, and data delivery for K to 12, postsecondary,  
13 continuing education, governmental, health, public service, and Indian  
14 community use.
