# EXECUTIVE BUDGET BILL

March 7, 1989, Introduced by Senator GAST and referred to the Committee on Appropriations.

A bill to make appropriations for the department of public health and substance abuse programs for the fiscal year ending September 30, 1990; to provide for the expenditure of those appropriations; to provide for reports; and to provide for the disposition of fees and other income received by the department of public health.

- 16 statement dated October 16, 1981, and in the "prenatal postpartum care,
- 17 proposed basic health service program statement" included in the department
- 18 document entitled "A Study of 20 Prenatal Care as a Basic Service," dated March
- 19 1, 1986, and for which the legislature has made funds available in amounts
- 20 necessary to ensure their availability and accessibility. The services
- 21 described in the statement are: immunizations, communicable disease control,
- 22 venereal disease control, tuberculosis control, prevention of gonorrhea eye
- 23 infection in newborns, screening newborns for phenylketonuria, screening

- 4 and career ladder development. The report shall specify the number of new
- 5 hires, promotions, and reallocations by civil service classification and grade
- 6 and by race, sex, and handicapping condition.
- 7 Sec. 206. To promote more effective management of the department, the
- 8 director of public health may utilize not more than 20 positions from any
- 9 appropriation account for functions in other department units which the
- 10 director of public health considers to be more critical to the management of
- 11 departmental programs. The department shall report quarterly to the department
- 12 of management and budget, the senate and house appropriations committees, and
- 13 the senate and house fiscal agencies on the transfer of positions and costs
- 14 pursuant to this part.
- 15 Sec. 207. If the federal and restricted funds used as a source of funding
- 16 for programs in section 101 are not received in the amount appropriated, the
- 17 department shall submit a report to the members of the house and senate
- 18 appropriations subcommittees on public health, house and senate fiscal
- 19 agencies, and the department of management and budget on the amount received by
- 20 type of federal and restricted funding and the planned allocations among
- 21 individual programs in comparison to appropriated amounts and originally
- 22 planned allocations. The report shall be submitted prior to the implementation
- 23 of any revised allocations.
- Sec. 208. The department shall provide a report on contractual services
- 25 to the senate and house appropriations subcommittees on public health and the
- 26 senate and house fiscal agencies each quarter. The report shall be based on

- 1 the monthly civil service statewide contracted services report required by
- 2 section 281 of the management and budget act, Act No. 431 of the Public Acts of
- 3 1984, being section 18.1281 of the Michigan Compiled Laws. The report shall
- 4 provide the name of the contractor, the dollar value of the contract,
- 5 description and location of the service to be provided, and justification for
- 6 the contract.
- 7 Sec. 209. The funds appropriated in section 101 for all grants to local
- 8 agencies shall not lapse at the end of the fiscal year, but shall continue to
- 9 be available for expenditure provided that an agreement has been executed
- 10 between the department and a responsible local agency or contractor prior to
- 11 September 15, 1990. The expenditure of such funds shall be in accordance with
- 12 the terms of the agreement.
- 13 Sec. 210. The amounts appropriated in section 101 for utilities and that
- 14 portion of contractual services, supplies, and materials used to pay for
- 15 utility service to state facilities may be expended in a manner consistent with
- 16 section 253 of the management and budget act, Act No. 431 of the Public Acts of
- 17 1984, being section 18.1253 of the Michigan Compiled Laws.
- 18 Sec. 211. The department may contract with the Michigan public health
- 19 institute for the design and implementation of projects and for other public
- 20 health related activities. The department shall report on potential projects
- 21 to be contracted with the institute, expected project duration, and project
- 22 cost to the house and senate appropriations subcommittees on public health,
- 23 senate and house fiscal agencies, and the department of management and budget
- 24 30 days before the signing of the contract. For purposes of this section, the
- 25 Michigan public health institute shall be considered a public health agency.
- 26 EXECUTIVE SERVICES

- 1 Sec. 301. Expenditures of federal or other restricted allotments from the
- 2 amounts appropriated in section 101 for federal and other restricted assistance
- 3 for health services shall not be made until after receipt of the
- 4 recommendations of the department of management and budget and the approval of
- 5 the public health subcommittees of the senate and house appropriations
- 6 committees. If any request for approval is not acted upon within 60 days after
- 7 the date of submission to the public health subcommittees of the senate and
- 8 house appropriations committees, the request shall be considered approved.
- 9 Sec. 302. Of the amount appropriated in section 101 from revenues from
- 10 fees and collections, not more than \$250,000.00 received from the sale of vital
- 11 records death data shall be used for improvements in the vital records and
- 12 health statistics program. The amount described in this section shall not
- 13 revert to the general fund at the end of the fiscal year ending September 30,
- 14 1990. Not later than December 1, 1990, the amount of any unexpended balances
- 15 and the proposed uses for those balances shall be reported to the department of
- 16 management and budget, the members of the senate and house subcommittees on
- 17 public health, and the senate and house fiscal agencies.
- 18 Sec. 303. The amount appropriated to the department in section 101 for
- 19 the post-polio education and referral project shall be used to provide for the
- 20 dissemination of information and educational materials to health care
- 21 professionals and polio survivors concerning the symptoms of the late effects
- 22 of polio and the resources available for evaluation, treatment, and
- 23 rehabilitation, the presentation of workshops and public information programs
- 24 to educate health professionals and the general public about the late effects
- 25 of polio, and other activities with health professionals and polio survivor
- 26 support groups to increase access to needed services for polio survivors.

- 1 Sec. 304. The funds appropriated in section 101 for the Vietnam veterans
- 2 agent orange program shall be considered a work project account that shall not
- 3 lapse at the end of the fiscal year.
- 4 COMMUNICABLE DISEASE CONTROL
- 5 Sec. 401. The department shall not pay for billings received for the care
- 6 and treatment of tuberculosis patients which are submitted more than 12 months
- 7 after the services are rendered.
- 8 Sec. 402. State funds appropriated in any other account in section 101
- 9 may be used to supplant not more than \$250,000.00 in federal funds projected
- 10 for immunization, if the federal funds are unavailable. The department shall
- 11 inform the senate and house appropriations subcommittees on public health,
- 12 senate and house fiscal agencies, and the department of management and budget
- 13 of the specific line items reduced pursuant to this section.

# 14 BIOLOGIC PRODUCTS

- 15 Sec. 501. The appropriations in section 101 for contracts for projects
- 16 and biologic products processing do not prohibit the department from charging
- 17 related activities to other appropriate operational accounts in the laboratory
- 18 services and biologic products appropriation units.
- 19 Sec. 502. Not later than December 1, 1990, the department shall report to
- 20 the department of management and budget, the members of the senate and house
- 21 appropriations subcommittees on public health, and the senate and house fiscal
- 22 agencies on the revenues received by and expended from the pharmaceutical
- 23 products fund created in section 9112 of the public health code, Act No. 368 of
- 24 the Public Acts of 1978, being section 333.9112 of the Michigan Compiled Laws.
- 25 Sec. 503. Biologic product sales by the Michigan department of public
- 26 health laboratories, pursuant to Act No. 279 of the Public Acts of 1982, shall

not be restricted to the production and sale of human pharmaceuticals, but shall be compatible with existing public health functions. Except in emergency situations as described by section 9111 of the public health code, Act No. 368 of the Public Acts of 1978, being section 333.9111 of the Michigan Compiled Laws, the department may determine the price of such products, which shall not be less than the actual cost of production. Revenues appropriated in section 1 from the biologic product sales program shall not lapse to the general fund at the end of the fiscal year ending September 30, 1990. The amount of any unexpended balances and proposed uses shall be reported to the department of management and budget and to the senate and house subcommittees on public health not later than December 1, 1990.

### 12 COMMUNITY ENVIRONMENTAL HEALTH

- Sec. 601. (1) The department shall not reimburse a claim by an operator of an agricultural labor camp pursuant to sections 12431 and 12432 of the public health code, Act No. 368 of the Public Acts of 1978, being sections 333.12431 and 333.12432 of the Michigan Compiled Laws, from the amount appropriated in section 101 for the migratory labor housing fund, until that portion of the labor camp utilized for migrant housing is in compliance with all state statutes and rules pertaining to the licensure of migrant labor camps as determined by on-site inspections both before and after occupancy.
- (2) The \$397,000.00 appropriated in section 101 for the migratory labor housing fund shall only be expended on projects started after January 1, 1985.

  The department of public health shall report before February 1, 1990, to the department of management and budget, the senate and house appropriations subcommittees on public health, and the senate and house fiscal agencies on the implementation of the utilization and program expenditures. The report shall

- 1 include the name of each agricultural labor camp that received a grant, the
- 2 amount of the grant for each agricultural labor camp, and any amount that was
- 3 received by the agricultural labor camp from any other governmental unit.
- 4 HEALTH CARE RESOURCES DEVELOPMENT AND REGULATION
- Sec. 701. The amount appropriated in section 101 for the EMS program
  - 6 shall include funding for regional contracts which shall include, at a minimum,
  - 7 EMS ambulance inspection, EMS personnel licensure examinations, review of
  - 8 training programs, and consultation.
  - 9 Sec. 702. Spending authorization is contingent upon actual fees being
- 10 received for the amount appropriated to the department in section 101 to fund
- 11 the increase of \$535,400 and 12.5 FTE positions in the certificate of need
- 12 (C.O.N.) program.
- 13 D. J. JACOBETTI VETERANS' FACILITY
- 14 Sec. 801. Notwithstanding Act No. 152 of the Public Acts of 1885, being
- 15 sections 36.1 to 36.12 of the Michigan Compiled Laws, the commandant of the D.
- 16 J. Jacobetti veterans' facility may give special consideration for admission to
- 17 handicapped veterans who have served in the armed forces of the United States
- 18 for less than 90 days and who have been honorably discharged.
- 19 CENTER FOR HEALTH PROMOTION
- 20 Sec. 901. The appropriations in section 101 for the Michigan model for
- 21 comprehensive school health education shall be used for contracts and services
- 22 for implementation efforts, including a school health materials center. The
- 23 contracts and services for implementation efforts relating to the school health
- 24 materials center and special projects shall be with central Michigan
- 25 university. The contracts and services shall be reviewed by the state
- 26 interagency steering committee and reported in their annual implementation plan.

- 1 Sec. 902. In developing and implementing AIDS provider education
- 2 activities, the department may provide funding to the Michigan state medical
- 3 society to serve as lead agency to convene a consortium of health care
- 4 providers, to design needed educational efforts, to fund other statewide
- 5 provider groups, and to assure implementation of these efforts, in accordance
- 6 with a plan approved by the department.
- 7 Sec. 903. On January 1, April 1, and July 1, 1990, the department shall
- 8 report to the members of the senate and house appropriations subcommittees on
- 9 public health, the senate and house fiscal agencies, and the department of
- 10 management and budget the number of laboratory tests pertaining to AIDS
- 11 actually performed by the department and any changes in the allocation of funds.
- 12 Sec. 904. The amount appropriated to the department in section 101 from
- 13 the Michigan health initiative fund represents an appropriation of \$9 million
- 14 and carry-forward authorization of \$2.25 million.
- 15 Sec. 905. The regional technical centers, established by the department
- 16 in section 101 under worksite risk reduction and health promotion grants, shall
- 17 provide upon request technical assistance for the establishment of employee
- 18 assistance programs.
- 19 Sec. 906. By January 1, 1990, the department shall submit an annual
- 20 report to the senate and house appropriations subcommittees on public health.
- 21 senate and house fiscal agencies, and the department of management and budget
- 22 regarding grants and services provided from the Michigan health initiative fund.
- 23 COMMUNITY SERVICES GRANTS TO LOCAL AGENCIES
- Sec. 1001. Of the amount appropriated in section 101 for low-income
- 25 prenatal care, not more than 10% may be expended for state and local
- 26 administration, data processing, and evaluation.

- 1 Sec. 1002. The department shall review the basis for the distribution of
- 2 funds to local health departments and other public and private agencies for the
- 3 women, infants, and children food supplement program; family planning; early
- 4 and periodic screening, diagnosis, and treatment program; and low-income
- 5 prenatal care program and indicate the basis upon which any projected
- 6 underexpenditures by local public and private agencies shall be reallocated to
- 7 other local agencies that demonstrate need.
- 8 Sec. 1003. A clinic, institution, or other health facility receiving
- 9 state funding for family planning purposes shall provide to a client seeking
- 10 family planning services, at initial contact, a pamphlet containing educational
- 11 information to assist the patient in making responsible parenting decisions.
- 12 The pamphlet shall include, but not be limited to, information regarding the
- 13 physical, financial, and time commitment involved in parenting. The pamphlets
- 14 required by this section shall be provided by the department. The pamphlets
- 15 shall be written in English and in clear, nontechnical terms. Copies of the
- 16 pamphlets shall also be printed in Spanish and distributed upon request to the
- 17 clinics, institutions, and other health facilities described in this section.
- 18 Sec. 1004. The amount appropriated in section 101 for state/local cost
- 19 sharing may be used for special grants to local health departments to satisfy
- 20 minimum funding levels prescribed by section 2477 of the public health code,
- 21 Act No. 368 of the Public Acts of 1978, being section 333.2477 of the Michigan
- 22 Compiled Laws, and any other authorized supplement. The special grants shall
- 23 not exceed a total of \$250,000.00.
- 24 Sec. 1005. For all programs appropriated in section 101 for community
- 25 services grants to local agencies unit, the department shall contract with
- 26 those local public and private nonprofit agencies best able to serve clients.

- 1 Factors to be used in the evaluation shall include ability to serve high-risk
- 2 population groups; ability to serve low-income clients, where applicable;
- 3 availability of, and access to, service sites; management efficiency; and
- 4 ability to meet federal standards, where applicable.
- 5 Sec. 1006. Expenditures for the early and periodic screening, diagnosis,
- 6 and treatment program, including state administration, and for the medical
- 7 review and nursing evaluation program, shall not exceed the actual amount of
- 8 funds available from the department of social services and any associated
- 9 federal matching funds.

## 10 CRIPPLED CHILDREN SERVICES

- 11 Sec. 1101. Money appropriated in section 101 for medical care and
- 12 treatment of crippled children shall be paid according to reimbursement
- 13 policies determined by the Michigan medical assistance program. Exceptions to
- 14 these policies may be taken with the prior approval of the department of
- 15 management and budget.
- 16 Sec. 1102. The department may do 1 or more of the following:
- 17 (a) Provide special formula for eligible clients with specified metabolic
- 18 and allergic disorders.
- (b) Provide medical care and treatment to eligible patients with cystic
- 20 fibrosis who are 21 years of age or older.
- 21 (c) Provide genetic diagnostic and counseling services for eligible
- 22 families.
- 23 (d) Provide medical care and treatment to eligible patients with
- 24 hereditary coagulation defects (hemophilia) who are 21 years of age or older.
- 25 Sec. 1103. A provider of service who does not submit a bill for care
- 26 related to part 58 of the public health code, Act No. 368 of the Public Acts of

- 1 1978, being sections 333.5801 to 333.5879 of the Michigan Compiled Laws, within
- 2 12 months after the date of service forfeits the right to payment and shall not
- 3 seek reimbursement from the recipient of the care nor from the recipient's
- 4 family or guardian.
- 5 SUBSTANCE ABUSE GRANTS AND CONTRACTS
- 6 Sec. 1201. This act does not prohibit the provision of programmatic or
- 7 financial support for the same or similar services by state departments other
- 8 than the office of substance abuse services.
- 9 Sec. 1202. The funds appropriated in section 101 for the SAPE program
- 10 shall be used to support regional drug education programs through contracts
- 11 with selected intermediate school districts. These state funds shall not be
- 12 expended unless the intermediate school district appropriates an amount equal
- 13 to 10% of the total program.
- Sec. 1203. Not more than \$47,400.00 may be expended from the amount
- 15 appropriated in section 101 for community substance abuse prevention,
- 16 education, and treatment grants to reimburse the department of state police for
- 17 fire inspection of substance abuse facilities.
- 18 Sec. 1204. Of the funds appropriated in section 101 for substance abuse,
- 19 not more than 10% of state administered funds may be expended for
- 20 administration of coordinating agencies.
- 21 Sec. 1205. Of the funds appropriated in section 101 for substance abuse
- 22 prevention, education, and treatment grants, not more than \$100,000.00 may be
- 23 utilized by the OSAS to implement fire and safety standards for local
- 24 residential services programs.
- 25 Sec. 1206. The amount appropriated in section 101 for substance abuse
- 26 prevention, education, and treatment grants shall be expended for contracting

- 1 with coordinating agencies or designated service providers.
- 2 Sec. 1207. The department shall not pay for services rendered under part
- 3 65 of the public health code, Act No. 368 of the Public Acts of 1978, being
- 4 sections 333.6501 to 333.6523 of the Michigan Compiled Laws, if the billings or
- 5 invoices for those services are submitted more than 12 months after the
- 6 services are rendered.
- 7 Sec. 1208. Of the amount appropriated in section 101 for community
- 8 substance abuse prevention, education, and treatment grants, \$992,500.00 shall
- 9 be for alcoholism and drug abuse services provided in residential and
- 10 outpatient settings to statewide medicaid and Wayne county general
- 11 assistance/resident county hospitalization substance abuse clients.
- 12 Sec. 1209. (1) On or before September 1, 1989, the office of substance
- 13 abuse services shall submit a program spending plan for the \$9,355,700 increase
- 14 in Governor's anti-drug abuse initiatives appropriated in section 101 to the
- 15 department of management and budget, and the senate and house appropriations
- 16 subcommittees on public health. Except as otherwise provided in subsection
- 17 (2), the plan shall not be implemented until the plan has been approved by the
- 18 department of management and budget, and the senate and house appropriations
- 19 subcommittees on public health.
- 20 (2) If the plan is not acted upon within 30 days by the senate and house
- 21 appropriation subcommittees on public health, the plan shall be considered
- 22 approved.
