

SENATE BILL No. 249

March 14, 1989, Introduced by Senators CARL, POSTHUMUS,
POLLACK, NICHOLS and O'BRIEN and referred to the
Committee on Finance.

A bill to amend Act No. 281 of the Public Acts of 1967,
entitled

"Income tax act of 1967,"

as amended, being sections 206.1 to 206.532 of the Michigan
Compiled Laws, by adding section 438.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Act No. 281 of the Public Acts of 1967, as
2 amended, being sections 206.1 to 206.532 of the Michigan Compiled
3 Laws, is amended by adding section 438 to read as follows:

4 SEC. 438. (1) A TAXPAYER WHO IS ENTITLED TO A TAX REFUND
5 FOR THE TAXABLE YEAR OF \$5.00 OR MORE MAY DESIGNATE THAT \$5.00 BE
6 PAID INTO THE HOMELESS SHELTER AND HOUSING REHABILITATION FUND
7 ESTABLISHED UNDER THE STATE HOUSING DEVELOPMENT AUTHORITY ACT OF
8 1966, ACT NO. 346 OF THE PUBLIC ACTS OF 1966, BEING SECTIONS
9 125.1401 TO 125.1498F OF THE MICHIGAN COMPILED LAWS. FOR A JOINT

1 RETURN, IF THE TAXPAYER'S TAX REFUND FOR THE TAX YEAR IS \$10.00
2 OR MORE, EACH SPOUSE MAY DESIGNATE THAT \$5.00 BE PAID TO THE
3 HOMELESS SHELTER AND HOUSING REHABILITATION FUND. THE DESIGNA-
4 TION AUTHORIZED BY THIS SECTION SHALL BE CLEARLY AND UNAMBIGU-
5 OUSLY PRINTED ON THE FIRST PAGE OF THE STATE INDIVIDUAL INCOME
6 TAX RETURN.

7 (2) NOTWITHSTANDING THE OTHER ALLOCATIONS AND DISBURSEMENTS
8 REQUIRED UNDER THIS ACT, AN AMOUNT EQUAL TO THE CUMULATIVE DESIG-
9 NATIONS MADE UNDER THIS SECTION, LESS THE AMOUNT APPROPRIATED TO
10 THE DEPARTMENT OF TREASURY FOR THE PURPOSES OF IMPLEMENTING THIS
11 SECTION, SHALL BE DEPOSITED IN THE HOMELESS SHELTER AND HOUSING
12 REHABILITATION FUND.

13 Section 2. This amendatory act shall not take effect unless

15 of the 85th Legislature is enacted into law.
