THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 7 of Act No. 306 of the Public Acts of

- 4 as follows:
- 5 Sec. 7. "Rule" means an agency regulation, statement, stan-
- 6 dard, policy, ruling, or instruction of general applicability
- 7 that implements or applies law enforced or administered by the
- 8 agency, or that prescribes the organization, procedure, or

- 1 practice of the agency, including the amendment, suspension, or
- 2 rescission thereof, but does not include the following:
- 3 (a) A resolution or order of the state administrative
- 4 board.
- 5 (b) A formal opinion of the attorney general.
- 6 (c) A rule or order establishing or fixing rates or7 tariffs.
- 8 (d) A rule or order pertaining to game and fish and promul-
- 9 gated under Act No. 230 of the Public Acts of 1925, as amended,
- 10 being sections 300.1 to 300.5 of the Michigan Compiled Laws, the
- 11 Michigan -sportsmen SPORTS fishing law, Act No. 165 of the
- 12 Public Acts of 1929, as amended, being sections 301.1 to 306.3 of
- 13 the Michigan Compiled Laws, and the game law of 1929, Act No. 286
- 14 of the Public Acts of 1929, as amended, being sections 311.1 to
- 15 315.5 of the Michigan Compiled Laws.
- (e) A rule relating to the use of streets or highways, the
- 17 substance of which is indicated to the public by means of signs
- 18 or signals.
- (f) A determination, decision, or order in a contested

- 21 (g) An intergovernmental, interagency, or intra-agency memo-
- 22 randum, directive, or communication that does not affect the
- 23 rights of, or procedures and practices available to, the public.
- 24 (h) A form with instructions, an interpretive statement, a
- 25 guideline, an informational pamphlet, or other material that in
- 26 itself does not have the force and effect of law but is merely
- 27 explanatory.

- 1 (i) A declaratory ruling or other disposition of a
- 2 particular matter as applied to a specific set of facts
- 3 involved.
- 4 (j) A decision by an agency to exercise or not to exercise a
- 5 permissive statutory power, although private rights or interests
- 6 are affected.
- 7 (k) Unless another statute requires a rule to be promulgated
- 8 under this act, a rule or policy that only concerns the inmates
- 9 of a state correctional facility and does not directly affect the
- 10 public. As used in this subdivision, "state correctional
- 11 facility" means a facility or institution that houses an inmate
- 12 population under the jurisdiction of the department of
- 13 corrections.
- 14 (1) All of the following, after final approval by the cer-
- 15 tificate of need commission or the statewide health coordinating
- 16 council under section 22215 or 22217 of the public health code,

- 18 and 333.22217 of the Michigan Compiled Laws:
- 19 (i) The designation, deletion, or revision of covered medi-
- 20 cal equipment and covered clinical services.
- 21 (ii) Certificate of need review standards.
- 22 (iii) Data reporting requirements and criteria for determin-
- 23 ing health facility viability.
- (iv) Standards used by the department of public health in
- 25 designating a regional certificate of need review agency.
- 26 (v) The modification of the 100 licensed bed limitation for
- 27 short-term nursing care programs set forth in section 22210 of

- 1 Act No. 368 of the Public Acts of 1978, being section 333.22210
- 2 of the Michigan Compiled Laws.
- 3 Section 2. This amendatory act shall not take effect unless
- 4 Senate Bill No. ____ or House Bill No. ____ (request
- 5 no. 01631'89) of the 85th Legislature is enacted into law.
