- 2 25 cents for each year covered by the abstract.
- 3 (b) For an abstract with A statement of name and residence
- 4 of taxpayers, 25 cents per year for each description of land cov-

- 6 (c) For A list of state tax lands or state bids, 25 cents
- 7 for each description of land on the list.
- 8 (d) For 1 copy of -any A paper or document, -at the rate
