- 4 SEC. 60B. (1) AN APPLICANT FOR ASSISTANCE UNDER THIS ACT
- 5 WHO IS, OR IS APPLYING ON BEHALF OF, AN INDIVIDUAL UNDER THE AGE
- 6 OF 18 WHOSE PARENT IS ABSENT FROM THE INDIVIDUAL'S HOME FOR REA-
- 7 SONS OTHER THAN THE PARENT'S DEATH SHALL COOPERATE WITH THE STATE
- 8 DEPARTMENT IN EFFORTS TO ESTABLISH PATERNITY AND OBTAIN SUPPORT
