- 3 (2) For the fiscal year ending September 30, 1988, of the
- 4 revenue from the increases in fees provided by the 1987 amenda-
- 5 tory act that added this section, \$1,350,000.00 shall be depos-
- 6 ited in the state treasury and credited to the general fund,
- 7 except that not more than \$500,000.00 shall be credited to the
- 8 gasoline inspection and testing fund created in section 8 of Act
- 9 No. 44 of the Public Acts of 1984, being section 290.648 of the
- 10 Michigan Compiled Laws, and \$100,000.00 shall be used for the
