SENATE BILL No. 523

July 26, 1989, Introduced by Senator WELBORN and referred to the Committee on Local Government and Veterans.

A bill to amend sections 6 and 7 of chapter IV of Act No. 283 of the Public Acts of 1909, entitled as amended

"An act to revise, consolidate and add to the laws relating to the establishment, opening, discontinuing, vacating, closing, altering, improvement, maintenance and use of the public highways and private roads, the condemnation of property and gravel therefor; the building, repairing and preservation of bridges; setting and protecting shade trees, drainage, cutting weeds and brush within this state, and providing for the election or appointment and defining the powers, duties and compensation of state, county, township and district highway officials,"

section 6 as amended by Act No. 299 of the Public Acts of 1982, being sections 224.6 and 224.7 of the Michigan Compiled Laws; and to add section 6a to chapter IV.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Sections 6 and 7 of chapter IV of Act No. 283 of

- 4 Sec. 6. (1) -In-any- UPON ADOPTION OF THE COUNTY ROAD
- 5 SYSTEM, THE COUNTY BOARD OF COMMISSIONERS SHALL BY RESOLUTION
- 6 DETERMINE THE NUMBER OF COUNTY ROAD COMMISSIONERS THAT SHALL CON-
- 7 STITUTE THE BOARD OF COUNTY ROAD COMMISSIONERS, WHICH NUMBER
- 8 SHALL NOT BE LESS THAN 3. THE COUNTY BOARD OF COMMISSIONERS MAY
- 9 BY RESOLUTION CHANGE THE NUMBER OF ROAD COMMISSIONERS CONSTITUT-

- 16 -or counties- the county board of commissioners may, by a major-
- 17 ity of its members elect, appoint the county road commissioners,
- 18 except as provided in subsection $\frac{(2)}{(5)}$. A county road com-
- 19 missioner appointed in that county shall not be removed from
- 20 office before the expiration of his or her term of office without
- 21 being given due written notice of the charges made against him or
- 22 her and an opportunity to appear before the county board of com-
- 23 missioners for a hearing on the charges. In any county in which
- 24 the board of road commissioners consists on August 28, 1929, of
- 25 less than 3 members, the county board of commissioners, at the
- 26 first regular meeting of the board after August 28, 1929, or at-a
- 27 special meeting called for that purpose, shall appoint additional

- 1 members as may be necessary. At the time of the appointment, the
- 2 county board of commissioners shall designate the date of expira-
- 3 tion of the initial term of each commissioner appointed in that
- 4 county, so that the term of a commissioner shall expire on
- 5 December 31 of each even year.
- 6 (5) -(2)— In a county having a population of 1,500,000 or
- 7 more which has adopted a charter under Act No. 293 of the Public

- 10 by law for a board of county road commissioners may be reorga-

- 19 (2) IN APPORTIONING THE COUNTY INTO ELECTION DISTRICTS, THE
- 20 COUNTY BOARD OF COMMISSIONERS SHALL BE GOVERNED BY THE GUIDELINES
- 21 SET FORTH IN SECTION 4 OF ACT NO. 261 OF THE PUBLIC ACTS OF 1966,
- 22 BEING SECTION 46.404 OF THE MICHIGAN COMPILED LAWS, IN THE ORDER
- 23 OF IMPORTANCE THERE STATED.
- 24 (3) AFTER APPROVAL BY THE COUNTY BOARD OF COMMISSIONERS, AN
- 25 APPORTIONMENT PLAN SHALL BE FILED IN THE OFFICE OF THE COUNTY
- 26 CLERK AND IS EFFECTIVE ON THE DATE OF THE FILING. THE COUNTY

- 9 (5) IF AN APPORTIONMENT PLAN IS FOUND CONSTITUTIONAL AND
- 10 CONSISTENT WITH THE PROVISIONS OF THIS ACT AND APPEALS ARE
- 11 EXHAUSTED, OR IF NO APPEAL IS TAKEN, WHEN THE TIME FOR APPEAL
- 12 EXPIRES, THAT PLAN IS THE OFFICIAL APPORTIONMENT PLAN FOR THE
- 13 BOARD OF COUNTY ROAD COMMISSIONERS UNTIL THE NEXT UNITED STATES
- 14 OFFICIAL DECENNIAL CENSUS FIGURES ARE AVAILABLE.
- 15 (6) ONE ROAD COMMISSIONER SHALL BE ELECTED FROM EACH
- 16 DISTRICT.
- 17 Sec. 7. (1) -Any- A person elected or appointed county road
- 18 commissioner shall, within 10 days after being notified in writ-
- 19 ing by the clerk of -such THE county of his OR HER election or
- 20 appointment, take and subscribe the constitutional oath of office
- 21 and file -the same IT with -said THE clerk. Each -and every-
- 22 county road commissioner shall -be-required to- execute and give

- 21 (3) IN A COUNTY APPOINTING ROAD COMMISSIONERS, THE MEMBERS
- 22 OF THE FIRST BOARD OF ROAD COMMISSIONERS APPOINTED AFTER A CHANGE
- 23 IN SIZE OF THE COUNTY ROAD COMMISSION PURSUANT TO SECTION 6 OF
- 24 THIS CHAPTER AND THE SUCCESSORS TO THE MEMBERS OF THE FIRST BOARD
- 25 OF ROAD COMMISSIONERS APPOINTED AFTER ADOPTION OF THE COUNTY ROAD

- 4 (4) THE TERMS OF THE ROAD COMMISSIONERS SHALL BE STAGGERED
- 5 IN A MANNER SPECIFIED BY RESOLUTION OF THE COUNTY BOARD OF COM-
- 6 MISSIONERS SO THAT, AS NEARLY AS POSSIBLE, THE SAME NUMBER OF
- 7 ROAD COMMISSIONERS ARE ELECTED OR APPOINTED BIENNIALLY. A member
- 8 of the COUNTY board of -supervisors shall be COMMISSIONERS IS
- 9 NOT eligible -to- FOR the office of county road commissioner, and
