SENATE BILL No. 534

July 27, 1989, Introduced by Senators DILLINGHAM, SCHWARZ, DE GROW, CARL, EHLERS, NICHOLS, BINSFELD, GEAKE and FESSLER and referred to the Committee on Education and Mental Health.

A bill to regulate the maintenance and operation of school buses; to prescribe the qualifications of school bus drivers; to prescribe the powers and duties of certain state agencies; and to prescribe penalties.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. This act shall be known and may be cited as "the
- 2 pupil transportation act".
- 3 Sec. 3. For the purposes of this act, the words and phrases
- 4 defined in sections 5 to 7 shall have the meanings respectively
- 5 ascribed to them in those sections.
- 6 Sec. 5. (1) "Modified school bus" means a school bus of any
- 7 age with a factory installed fuel system which has been modified
- 8 to operate on a fuel source other than gasoline or diesel fuel.
- 9 (2) "Pupil transportation vehicle" means any vehicle other
- 10 than a school bus used to transport pupils to or from school or

- 1 school-related events. Pupil transportation vehicle does not
- 2 include a vehicle operated by a municipally owned transportation
- 3 system or by a carrier certified by the Michigan public service
- 4 commission.
- 5 (3) "Rehabilitated school bus" means a bus which is at least
- 6 4 years old and has accumulated at least 100,000 miles, or is 7
- 7 years old; and which has been thoroughly inspected and had all
- 8 systems repaired, replaced, or adjusted to meet the department of
- 9 state police inspection requirements including but not limited
- 10 to:
- (a) Engine overhaul of short block.
- 12 (b) New tires on the front axle.
- (c) New recap tires on the rear axle.
- (d) New brake linings and drums.
- (e) New hydraulic brake lines.
- (f) Front and rear springs.
- 17 (g) New paint in the interior.
- (h) New exhaust system.
- 19 (4) "Rule" means a rule promulgated pursuant to the adminis-
- 20 trative procedures act of 1969, Act No. 306 of the Public Acts of
- 21 1969, being sections 24.201 to 24.328 of the Michigan Compiled
- 22 Laws.
- Sec. 7. (1) "School bus" means a motor vehicle, other than
- 24 a station wagon or passenger van, with a manufacturer's rated
- 25 seating capacity of 16 or more pupils used for the transportation
- 26 of school pupils to and from school which either is owned by a
- 27 school district or, if privately owned, is transporting school

- ! pupils under a contract with a local school district, a local act
- 2 school district, or an intermediate school district. School bus
- 3 does not include a vehicle operated by a municipally owned trans-
- 4 portation system or by a carrier certified by the Michigan public
- 5 service commission. As used in this subsection:
- 6 (a) "Passenger van" means a motor vehicle designed to carry
- 7 not more than 15 passengers, built on a truck chassis, and regis-
- 8 tered and titled by the secretary of state as a station wagon.
- 9 (b) "Station wagon" means a motor vehicle designed to carry
- 10 not more than 10 passengers and built on a passenger vehicle
- 11 chassis.
- 12 (2) "Type I school bus" means a school bus with a gross
- 13 vehicle weight rating of more than 10,000 pounds.
- (3) "Type II school bus" means a school bus with a gross
- 15 vehicle rating of 10,000 pounds or less.
- 16 (4) "Type I premium school bus" means a school bus with a
- 17 passenger capacity of over 66 pupils and any other school bus
- 18 purchased by a district at a cost for the vehicle, excluding
- 19 interest and special equipment, which exceeds by more than 15%
- 20 the average cost of a school bus meeting state minimum specifica-
- 21 tions of the same capacity purchased during the same year.
- Sec. 9. The state board of education shall regulate pupil
- 23 transportation. The state board shall promulgate rules as neces-
- 24 sary to implement this act pursuant to the administrative proce-
- 25 dures act of 1969, Act No. 306 of the Public Acts of 1969, being
- 26 sections 24.201 to 24.328 of the Michigan Compiled Laws.

- 1 Sec. 10. Each motor vehicle owned by a public, private, or
- 2 governmental agency and operated for the transportation of
- 3 children to or from school or privately owned and operated for
- 4 compensation for the transportation of children to or from school
- 5 shall meet the passenger protection federal motor vehicle safety
- 6 standards applicable to the construction and sale of school
- 7 buses.
- 8 Sec. 11. (1) This section and sections 13 to 21 apply to
- 9 both type I and type II school buses except where specifically
- 10 provided otherwise.
- 11 (2) A type I school bus shall have an outside body width of
- 12 not more than 96 inches; an outside overall length of not more
- 13 than 40 feet; and an inside height of not less than 72 inches,
- 14 aisle floor surface to ceiling. A type II school bus shall have
- 15 an outside body width of not more than 96 inches; and an inside
- 16 height of not less than 60 inches, aisle floor surface to
- 17 ceiling.
- 18 (3) A bus shall be attached firmly to the chassis. A spacer
- 19 shall be inserted between the body and the frame at every point
- 20 of contact so that shearing stresses are not put on rivet heads.
- 21 (4) A bus floor shall be of metal at least equal in strength
- 22 to 14-gauge steel and so constructed and maintained that exhaust
- 23 gases cannot enter the bus. The floor, including wheelhousing,
- 24 shall be covered and maintained with 1/8-inch smooth rubber. The
- 25 aisles shall be covered and maintained with 3/16-inch ribbed
- 26 rubber. The rib-aisle shall continue to the stepwell. Metal
- 27 longitudinal strips shall be applied to the aisle seams. Floors

- 1 shall be coved to the walls. All closures between the body and
- 2 the engine compartment shall be fitted with gaskets which effec-
- 3 tively prevent gas from entering the body. The bus body floor,
- 4 cross members, and skirts shall be completely undercoated. A
- 5 transmission inspection plate, if any, need not be rubber-covered
- 6 but shall be firmly attached. Plywood floors are optional.
- 7 (5) Sedan-type doors shall not be used on type I school
- 8 buses. When a jackknife-type service door is used, it shall fold
- 9 forward toward the front of the bus. If a split-type service
- 10 door is used, it shall open outward. Sedan-type doors may be
- 11 used on service entrances of type II buses. The steps of a serv-
- 12 ice door entrance shall be covered with 3/16-inch molded ribbed
- 13 rubber or other nonslip surface.
- 14 (6) An emergency exit shall be provided as follows:
- 15 (a) Type I school bus: the upper and lower portion of the
- 16 central rear emergency door shall be equipped with approved
- 17 safety glass. The door shall be hinged on the right side and the
- 18 door handle located on the extreme left. Piano hinges shall not
- 19 be used. The handle shall be in the vertical position when
- 20 latched. A locking device of any kind shall not be attached to,
- 21 or made a part of, the emergency door.
- 22 (b) Type II school bus: subdivision (a) applies to type II
- 23 buses except that body gauge metal may be substituted for safety
- 24 glass in the lower portion of the rear emergency door, and double
- 25 rear emergency doors may be used. A double rear emergency door
- 26 shall have a 3-point latch.

- 1 (7) A bus body shall be lined with fiberglass or a
- 2 comparable nonsettling, nonabsorbent insulation.
- 3 (8) Book racks shall not be installed in a school bus.
- 4 (9) The electrical system shall be 12 volt D.C. provided
- 5 through an alternator with a minimum of 100 amp rating and a min-
- 6 imum battery storage capacity of 500 CCA with gasoline engine, or
- 7 900 CCA with diesel engine provided through 1 12-volt battery, 2
- 8 12-volt batteries, or 2 6-volt batteries. There shall not be an
- 9 opening through the floor of the bus to service the battery.
- 10 Sec. 13. (1) A school bus seating 60 or more passengers and
- 11 manufactured after January 1, 1971, shall be equipped with an air
- 12 brake system. A bus shall be equipped with an emergency stopping
- 13 system designed and constructed to permit modulated control of
- 14 brake application and release, and to prevent release by the
- 15 driver unless energy is available for reapplication. The brake
- 16 system shall be provided with an electrically heated moisture
- 17 ejector on each air reservoir. Each air reservoir in the system
- 18 shall be equipped with a manual petcock valve on the bottom of
- 19 the tank. If the automatic moisture ejection valve is equipped
- 20 with a manual drain control or built-in petcock, a separate
- 21 manual petcock is not required. The air reservoir tanks shall be
- 22 mounted on the chassis frame with not less than 15 inches clear-
- 23 ance between the ground and the lowest part of the tank or tank
- 24 component.
- 25 (2) The automatic transmission shall have not less than 4
- 26 forward gear ratios. On type II school buses, the automatic

- I transmission shall have not less than 3 forward gear ratios. The
- 2 manual shift transmission is optional.
- 3 Sec. 15. (1) A school bus shall be equipped with class A
- 4 turn signal lamps. A lamp used on a bus more than 80 inches wide
- 5 shall project illumination of an area of not less than 12 square
- 6 inches measured on a plane at right angles to the axis of the
- 7 lamp. These signals shall be independent units equipped with a
- 8 4-way hazard warning switch to cause simultaneous flashing of
- 9 turn signal lamps when needed as a vehicular traffic hazard
- 10 warning. The front turn signal lights shall be double-faced and
- 11 side-mounted.
- 12 (2) Alternately flashing stop lights shall comply with
- 13 section 27. They shall be operated by a manually operated switch
- 14 and detached from any other instrument on the bus. A flashing
- 15 light shall not be connected to the brakes or the service door.
- 16 A 3-inch black area shall be provided around sealed beam flasher
- 17 lamps front and rear. Lamps indicating alternating flashing
- 18 light operation shall be visible to the driver.
- 19 (3) The location of all exterior lamps and signals shall be
- 20 in conformance with current United States department of transpor-
- 21 tation, federal motor carrier safety regulations, and with this
- 22 act, where applicable.
- 23 (4) Tail lamps and signals shall be positioned as follows:
- 24 (a) Two red 7-inch diameter combination stoptail lamps shall
- 25 be mounted on the rear of the bus at a height of not less than 15
- 26 inches or more than 72 inches above the surface upon which the

- 1 unloaded bus rests, and shall be positioned as far apart as
 2 practicable.
- 3 (b) Turn signals at the rear of a bus shall be 7 inches in
- 4 diameter with amber lens and shall be mounted on the same level
- 5 and outboard of the stoptail lamp combination unit.
- 6 (5) Beginning October 1, 1990, the replacement of any equip-
- 7 ment required by this section shall comply with section 16.
- 8 Sec. 16. (1) A school bus shall be equipped with 2 red
- 9 lamps at the rear of the vehicle and 2 red lamps at the front of
- 10 the vehicle.
- 11 (2) In addition to the 4 red lamps described in
- 12 subsection (1), 4 amber lamps shall be installed near each red
- 13 signal lamp, at the same level, but closer to the vertical center
- 14 line of the bus. The system of red and amber signal lamps shall
- 15 be wired so that the amber lamps are energized manually, and the
- 16 red lamps are automatically energized, with the amber lamps being
- 17 automatically de-energized, when the bus service door is opened.
- 18 (3) The area around the lens of each alternately flashing
- 19 signal lamp and extending outward approximately 3 inches shall be
- 20 painted black. In installations where there is no flat vertical
- 21 portion of body immediately surrounding the entire lens of a
- 22 lamp, a circular or square band of black approximately 3 inches
- 23 wide, immediately below and to both sides of a lens, shall be
- 24 painted on the body or roof area against which the signal lamp is
- 25 seen from a distance of 500 feet along the axis of the vehicle.
- 26 Visors or hoods with an appropriate black background to fit their
- 27 shape and roofcap may also be used. The amber and red lights

- 1 shall have sufficient intensity to be visible from a distance of
- 2 not less than 500 feet in normal sunlight.
- 3 Sec. 17. (1) A school bus shall be equipped with 2 wind-
- 4 shield wipers and 2 windshield washers. A washer reservoir shall
- 5 be 70 ounces or more.
- 6 (2) A windshield shall be slanted to prevent glare and large
- 7 enough to permit the driver to see the road clearly.
- 8 (3) All glass shall be safety glass and shall comply with
- 9 the requirements of section 23, where applicable.
- 10 Sec. 19. (1) A school bus shall be equipped with an indi-
- 11 rect vision mirror system which will provide a clear unobstructed
- 12 view of the area in front of the bus and the area in front and
- 13 immediately adjacent to the left and right front wheels. The
- 14 mirror system shall:
- (a) Consist of mirrors convex in shape, at least 7-1/2
- 16 inches in diameter with adjustable mirror heads, firmly mounted
- 17 at the hood or fender of the bus in a manner as not to present an
- 18 obstruction to the driver's direct view of pedestrians in front
- 19 of the bus.
- 20 (b) Permit the seated bus driver to see the area immediately
- 21 in front of each front wheel, below and 6 inches behind the front
- 22 vertical plane of the front bumper and the area forward of the
- 23 front bumper to a point where the driver, by direct vision, may
- 24 see a pedestrian crossing in front of the bus.
- (2) The interior mirror shall be clear view, tempered safety
- 26 glass with a reflective surface of 6 inches in height by 30
- 27 inches in width for type I buses, and shall be metal-backed and

- 1 framed. It shall have rounded corners and padded edges.
- 2 Interior mirrors for type II buses shall have a reflective sur-
- 3 face of 6 inches in height by 15 inches in width and shall be
- 4 protected by framing and padding as for type I buses.
- 5 (3) Sun shades, if installed, shall be mounted so that the
- 6 mounting brackets are not likely to cause injury in the event of
- 7 an accident.
- 8 Sec. 21. (1) A school bus shall be equipped with at least
- 9 1, 2A-10BC dry chemical fire extinguisher, or its equivalent,
- 10 which is approved by underwriters' laboratories, incorporated and
- 11 which has an aluminum, brass, or bronze valve. The extinguisher
- 12 shall be mounted securely in an accessible place in the driver's
- 13 compartment and shall be in satisfactory operating condition at
- 14 all times.
- 15 (2) A bus shall be equipped with a first aid kit which shall
- 16 be firmly mounted with a quick release bracket in an accessible
- 17 location in the driver's compartment and which shall contain, at
- 18 a minimum, all of the following:
- 19 (a) Bandage compress (sterile gauze
- 21 (b) Bandage compress (sterile gauze
- 22 pads), 2-inch...... 2 packages.
- 24 (d) Triangular bandage with 2 safety
- 25 pins, 40-inch..... 1 package.
- 26 (e) Roll gauze..... 1 package.

- 1 (f) Elastic bandage, 3-inch...... 1 package.
- 2 Antiseptics and burn ointments shall not be included, except 3 as required by the public service commission.
- 4 (3) A bus shall be equipped with 3 bidirectional emergency
- 5 reflective triangles which are properly cased and securely
- 6 mounted and 3 red-burning fusees which are capable of burning not
- 7 less than 15 minutes and which are properly cased and securely
- 8 mounted in the driver's compartment. Fusees and reflectors shall
- 9 comply with the standards set forth in this act and the rules
- 10 promulgated pursuant to this act.
- 11 Sec. 23. (1) A person shall not sell a new motor vehicle
- 12 nor shall a new motor vehicle be registered thereafter which is
- 13 designed or used as a school bus unless that vehicle is equipped
- 14 with safety glass wherever glass is used in doors, windows, and
- 15 windshields. Rigid safety plastic which meets the test require-
- 16 ments of American national standards institute standard
- 17 Z26.1-1966 may be used on buses in lieu of safety glass, except
- 18 that front windshields shall be equipped with safety glass. The
- 19 superintendent of public instruction shall specify that school
- 20 buses shall be fitted with at least 1 push-out window sash on
- 21 each side of any bus on which the plastic panes are installed.
- 22 (2) As used in this section, "safety glass" means a product
- 23 composed of glass, so manufactured, fabricated, or treated as
- 24 substantially to prevent shattering and flying of the glass when
- 25 struck or broken.
- 26 Sec. 25. Any part of a gasoline tank or container or intake
- 27 pipe shall not be located within or above the passenger-carrying

- 1 portion of a school bus unless securely sealed off from that
- 2 portion by means of a substantial metal cover. The gasoline con-
- 3 tainer, including intake pipe, cap and vent on a school bus manu-
- 4 factured subsequent to December 31, 1964, shall be so designed
- 5 that, in the event of overturn, the gasoline will not be spilled
- 6 at a rate in excess of 1 ounce per minute.
- 7 Sec. 27. (1) A school bus transporting pupils outside of
- 8 incorporated cities or villages and inside of incorporated cities
- 9 or villages where stopping of school buses is controlled by local
- 10 ordinance shall be painted and shall contain signs on the back
- 11 and front of the school bus as approved by the state transporta-
- 12 tion department and the superintendent of public instruction.
- 13 (2) The driver of the school bus, before resuming motion,
- 14 shall deactivate flashing lights and permit stopped traffic to
- 15 proceed and shall, when resuming motion, proceed in a manner
- 16 which will allow congested traffic to disperse by keeping the bus
- 17 as near to the right side of the road as can be done with
- 18 safety. Passengers crossing the road upon being discharged from
- 19 a school bus shall cross in front of the stopped school bus. At
- 20 an intersection where traffic is controlled by an officer or a
- 21 traffic stop-and-go signal a vehicle need not be brought to a
- 22 full stop before passing a stopped school bus, but may proceed
- 23 past the school bus at a speed not greater than is reasonable and
- 24 proper but not greater than 10 miles an hour and with due caution
- 25 for the safety of passengers being received or discharged from
- 26 the school bus. This subsection shall not be applicable to buses
- 27 inside incorporated cities or villages, but shall apply to a

- 1 school bus transporting passengers on a boundary street of an
- 2 incorporated city or village. Where the stopping for school
- 3 buses is controlled by local ordinance, the ordinance shall be
- 4 enforceable when signs giving notice of the local traffic regula-
- 5 tion are posted upon or at the entrance to the area or part of
- 6 the area affected as may be most appropriate or sufficiently leg-
- 7 ible as to be seen by an ordinarily observant person. The driver
- 8 of a vehicle who fails to stop for a school bus as required by
- 9 this subsection, who passes a school bus in violation of this
- 10 subsection, or who fails to stop for a school bus in violation of
- 11 an ordinance which complies with this subsection, is guilty of a
- 12 misdemeanor.
- 13 (3) A school bus driver shall not stop the bus for the pur-

- 14 pose of receiving or discharging passengers, unless the bus is
- 15 completely visible in its stopped position to approaching or
- 16 overtaking drivers of vehicles for a distance of at least 400
- 17 feet.
- 18 (4) The driver of a vehicle upon a highway which has been
- 19 divided into 2 roadways by leaving an intervening space, or by a
- 20 physical barrier, or clearly indicated dividing sections so con-
- 21 structed as to impede vehicular traffic, need not stop upon meet-
- 22 ing a school bus which has stopped across the dividing space,
- 23 barrier, or section.
- 24 (5) A school bus transporting pupils outside of incorporated
- 25 cities or villages and inside of incorporated cities or villages
- 26 where stopping of school buses is controlled by local ordinance,
- 27 in addition to any other equipment and distinctive marking

- 1 required by law, shall be equipped with signal lamps mounted as
- 2 high and widely spaced laterally as practicable which shall be
- 3 capable of displaying to the front 2 alternately flashing red
- 4 lights located at the same level and to the rear 2 alternately
- 5 flashing red lights located at the same level. The lights shall
- 6 have sufficient intensity to be visible from a distance of not
- 7 less than 500 feet in normal sunlight and shall be actuated by
- 8 the driver of the school bus when, but only when, the vehicle is
- 9 stopped and for a distance of at least 200 feet in advance of a
- 10 stop for the purpose of receiving or discharging school
- 11 children. The lights shall not be actuated inside of incorpo-
- 12 rated cities or villages unless stopping of school buses is con-
- 13 trolled by local ordinance. A school bus operating on a public
- 14 highway and transporting passengers primarily other than school
- 15 pupils shall not have the alternately flashing red lamps in
- 16 operation.
- (6) A school bus shall be equipped with flashing red lights
- 18 which shall be actuated by the driver only when the school bus is
- 19 stopped or stopping on a highway pursuant to this section. A
- 20 school bus may also be equipped with a flashing, oscillating, or
- 21 rotating light mounted on the roof of the bus approximately 6
- 22 feet from the rear of the vehicle which displays a white light to
- 23 the front, side, and rear of the bus which light may be actuated
- 24 by the driver for use only in inclement weather such as fog,
- 25 rain, or snow, or when the school bus is stopped or stopping on a
- 26 highway pursuant to this section, or where conditions hinder the
- 27 visibility of the school bus.

- 1 (7) A school bus shall be equipped with a mirror, convex in 2 shape, at least 7-1/2 inches in diameter firmly mounted at hood 3 or fender top height in front of the bus. The mirror shall be 4 located on either the left or right side of the bus in a manner 5 so that the seated driver may observe through its use the road 6 from the front bumper forward to the point where direct observation is possible.
- 8 (8) In a proceeding for a violation of subsection (2), proof
 9 that the particular vehicle described in the citation, complaint,
 10 or warrant was in violation of subsection (2), together with
 11 proof that the defendant named in the citation, complaint, or
 12 warrant was, at the time of the violation, the registered owner
 13 of the vehicle, shall constitute in evidence a presumption that
 14 the registered owner of the vehicle was the driver of the vehicle
 15 at the time of the violation.
- (9) Except as otherwise provided in subsection (2), a person17 who violates this section is responsible for a civil infraction.
- 18 Sec. 29. (1) A school bus transporting pupils outside of 19 incorporated cities or villages and inside of incorporated cities 20 or villages where stopping of school buses is controlled by local 21 ordinance shall be painted and shall contain signs on the back 22 and front of the school bus as approved by the state transporta-23 tion department and the superintendent of public instruction.
- (2) Each school bus purchased or repainted shall be painted,
 25 with the exception of trim, national school bus chrome yellow, as
 26 specified by the national bureau of standards specification.
 27 Body trim, if used, shall be black. The name of the school

- 1 district shall be painted in black on the back, front, and sides
 2 of the bus.
- 3 (3) A bus, not engaged in the transportation of school
- 4 pupils, either part-time or full-time, shall not be painted in
- 5 colors and design specified in subsection (2).
- 6 (4) The state board and law enforcement officers shall
- 7 enforce the requirements of this section.
- 8 Sec. 31. (1) Standards prescribed in this act for a school
- 9 bus apply to buses manufactured subsequent to 1977. Copies of
- 10 the standards in composite form shall be made available from the
- 11 department of education at no cost.
- 12 (2) A school bus which is not painted school bus chrome
- 13 yellow and is being operated by a municipally-owned transporta-
- 14 tion system or by a common passenger carrier certificated by the
- 15 public service commission on the date this act takes effect is
- 16 not required to be painted school bus chrome yellow or identified
- 17 as a school bus until it is repainted. A school bus not painted
- 18 school bus chrome yellow shall be subject only to sections 11(3),
- 19 (6), and (7), 15(3), 17, 19, 21, 35, and 37(3), (4), and (5).
- 20 Sec. 33. A school bus shall be marked as required by
- 21 department of education standards for school bus markings and
- 22 operational procedures available from the department of education
- 23 at no cost. As an exception to these standards, animal pictures,
- 24 cartoon figures, and similar insignia may be affixed to the bus
- 25 in a temporary manner near the entrance door to assist in identi-
- 26 fying the bus route. A school bus shall be painted as follows:

- 1 (a) The body, cowl, hood, and fenders shall be national
 2 school bus chrome yellow.
- 3 (b) The bumper, body trim, wheels, and lettering shall be
- 4 black. The wheel rims shall be gray, black, or natural, as pro-
- 5 vided by the manufacturer.
- 6 (c) The wheel covers, if painted, shall be black.
- 7 (d) The grill, if not chrome, shall be national school bus
 8 chrome yellow.
- 9 (e) The mirrors, if painted, shall be black or yellow.
- 10 Sec. 35. A school bus shall have, in operating condition,
- 11 all equipment required by this act.
- 12 Sec. 37. (1) The state board shall promulgate rules for
- 13 safety specifications for school buses transporting pupils to
- 14 public and nonpublic schools.
- 15 (2) The department of state police shall inspect each school
- 16 bus annually, and more frequently in a school district where bus
- 17 defects have been found, to determine if the bus meets the speci-
- 18 fications of the state board. The department of state police may
- 19 delegate the inspection of school buses to publicly employed
- 20 inspectors if the inspection complies with this section.
- 21 (3) Inspection of a school bus may be accomplished at any
- 22 time, at any location, on or off a school district site, and as
- 23 frequently as the department of state police considers necessary
- 24 to secure passenger safety. A bus may be rejected by the
- 25 inspecting state police official for further use in transporta-
- 26 tion of school children if it does not meet the requirements of
- 27 this act or if the conditions for rejection of a school bus are

- 1 not corrected while the official is present. However, if a bus
- 2 is determined to be safe for operation even though in unsatisfac-
- 3 tory condition, the official may determine that not more than 60
- 4 days shall be allowed to effect a specific repair.
- 5 (4) A school bus determined by a department of state police
- 6 official to be unsafe for further operation as a school bus shall
- 7 not be used in the transportation of any child. The bus shall
- 8 have affixed on its windshield by the official a statement "This
- 9 bus may not be driven in the transportation of any child.
- 10 Failure to obey this statement is cause for arrest." The state-
- 11 ment shall remain until its removal is authorized by a department
- 12 of state police official.
- 13 (5) A bus determined to be in unsatisfactory condition but
- 14 safe for operation as a school bus for a limited period of time
- 15 shall have affixed on its windshield by the inspecting official a
- 16 statement "This bus has equipment defects. Repairs and reinspec-
- 17 tion shall be obtained on or before . Removal of this
- 18 notice from the bus without reinspection is cause for arrest."
- 19 The statement shall remain until its removal is authorized by a
- 20 department of state police official.
- 21 (6) A bus whose major use is the transportation of school
- 22 pupils shall carry at least 1 fire extinguisher as a matter of
- 23 public safety.
- 24 (7) A board of education, employee of a school district, or
- 25 other person having control over the operation of a school bus
- 26 shall not operate or permit to be operated a school bus which has
- 27 not been inspected under this section.

- 1 (8) A school bus shall meet the specifications for school 2 buses prescribed by this act and the rules promulgated pursuant 3 to this act.
- 4 (9) The department of state police shall inspect a new 5 school bus before a school board or intermediate school board 6 accepts delivery of the new school bus. The department of state 7 police shall determine whether the new school bus is acceptable 8 for delivery. The department of state police may delegate the 9 inspection of new school buses to publicly employed inspectors if 10 the inspection complies with this subsection. A school board 11 shall not accept delivery of a new school bus unless the new 12 school bus has been inspected and granted final approval by the 13 department of state police under this subsection and title to the 14 school bus has been obtained by the school board in compliance 15 with this act.
- (10) A modified school bus which uses compressed natural 17 gas, liquefied natural gas, or liquefied petroleum gas shall not 18 be used to transport pupils unless the installation of the fuel 19 system has been inspected and approved as safe by the department 20 of state police.
- Sec. 39. A school bus subject to inspection pursuant to

 22 this act that is, in whole or in part, school bus chrome yellow

 23 or any color commonly referred to as yellow, and that is engaged

 24 in the transportation of pupils shall comply with the require
 25 ments for school buses set forth in this act or rules promulgated

 26 pursuant to this act; except that buses manufactured before

 27 July 15, 1982 and that have a rated seating capacity of 60 or

- 1 more passengers are not required to be equipped with an air brake
 2 system.
- Sec. 41. (1) A school bus may be rejected by the inspecting
- 4 state official for use in transporting passengers if it does not
- 5 meet the requirements of this act or rules promulgated pursuant
- 6 to this act or if the conditions responsible for the rejection of
- 7 the bus are not corrected while the official is present.
- 8 (2) A vehicle that is determined by a state police official
- 9 to be unsafe for further operation as a school bus shall not be
- 10 used in the transportation of any passengers. An unsafe vehicle
- 11 shall have affixed to its windshield, by the state police offi-
- 12 cial, a red sticker which shall read as follows: "This bus may
- 13 not be driven in the transportation of any passenger.
- 14 Utilization of this vehicle to transport passengers is in viola-
- 15 tion of law. [reverse side] Do not remove without State Police
- 16 authorization." The sticker shall remain until the vehicle is
- 17 reinspected by a state police official.
- 18 (3) A school bus that is considered to be in unsatisfactory
- 19 condition, but that is safe for operation, shall have affixed to
- 20 its windshield by the state police official a yellow sticker
- 21 which shall read as follows: "This bus has equipment
- 22 defects.[reverse side] Repairs and reinspection shall be obtained
- 23 on or before . Do not remove without State Police
- 24 authorization." The sticker shall remain until the vehicle is
- 25 reinspected by a state police official. If, upon reinspection,
- 26 the vehicle defect has not been repaired, replaced, or corrected,
- 27 the state police official shall remove the yellow sticker and

- 1 affix a red sticker to the vehicle. Exceptions may be made when
- 2 the necessary parts or equipment has been ordered but not
- 3 received at the time of reinspection. Reinspection may take
- 4 place within 60 days after the original inspection.
- 5 (4) A bus that is considered to be in satisfactory condition
- 6 after inspection by a state police official shall have a Michigan
- 7 vehicle inspection passing sticker affixed to its windshield.
- 8 Sec. 43. (1) A school bus with a manufacturers rated seat-
- 9 ing capacity of 12 or more which is owned, leased, or used by a
- 10 nonpublic school, religious organization, nonprofit youth organi-
- 11 zation, nonprofit rehabilitation facility, or senior citizen
- 12 center for the transportation of passengers shall not be operated
- 13 on a highway unless the vehicle has been inspected as provided in
- 14 this section.
- 15 (2) The department of state police shall inspect each school
- 16 bus with a manufacturers rated seating capacity of 12 or more,
- 17 which is owned, leased, or used by a nonpublic school, religious
- 18 organization, nonprofit youth organization, nonprofit rehabilita-
- 19 tion facility, or senior citizen center for the transportation of
- 20 passengers, annually, and more frequently if defects are found in
- 21 the organization's vehicles, to determine if the vehicles meet
- 22 the specifications of the department of state police. The
- 23 department of state police may delegate the inspection of vehi-
- 24 cles under this section to publicly employed inspectors if the
- 25 inspections comply with this section.
- 26 (3) The department of state police shall promulgate rules
- 27 for safety equipment for a school bus regulated under this

- 1 section pursuant to the administrative procedures act of 1969,
- 2 Act No. 306 of the Public Acts of 1969, being sections 24.201 to
- 3 24.328 of the Michigan Compiled Laws.
- 4 Sec. 45. A certificate of title for a school bus shall be
- 5 issued to a school board that has purchased the school bus by the
- 6 secretary of state only after a manufacturer's statement of
- 7 origin has been provided to the secretary of state. If the body
- 8 and chassis of a school bus are not built by the same manufactur-
- 9 er, a certificate of title for the school bus shall be issued to
- 10 a school board by the secretary of state only after a
- 11 manufacturer's statement of origin has been provided by the body
- 12 dealer and chassis dealer to the secretary of state.
- 13 Sec. 47. (1) A person, whether or not licensed under the
- 14 Michigan vehicle code, Act No. 300 of the Public Acts of 1949,
- 15 being sections 257.1 to 257.923 of the Michigan Compiled Laws,
- 16 who is 17 years of age or less shall not drive a motor vehicle
- 17 while in use as a school bus for the transportation of pupils.
- 18 Before driving a school bus, a person shall pass annual physical
- 19 and driver competence examinations as authorized by the superin-
- 20 tendent of public instruction. The tests shall be made available
- 21 annually in each of the intermediate school districts. A person
- 22 regularly employed as a school bus driver shall not drive a motor
- 23 vehicle while in use as a school bus without possessing a valid
- 24 chauffeur's license and a class 3 indorsement under section 312e
- 25 of the Michigan vehicle code, Act No. 300 of the Public Acts of
- 26 1949, being section 257.312e of the Michigan Compiled Laws. A
- 27 person shall not operate a school bus unless that person

- 1 possesses a valid chauffeur's license and a class 3 indorsement
- 2 under section 312e, Act No. 300 of Public Acts of 1949, being
- 3 section 257.312e of the Michigan Compiled Laws.
- 4 (2) Upon receiving proper application from a person who is
- 5 18 years of age or older who holds a valid operator's or
- 6 chauffeur's license, the secretary of state may issue a temporary
- 7 instruction permit entitling the person while carrying the permit
- 8 to drive a school bus for a period of 150 days, but only when
- 9 accompanied by a licensed adult operator or chauffeur who is
- 10 licensed with the appropriate vehicle group designation and
- 11 indorsement and who is actually occupying a seat behind the
- 12 driver if the permittee is driving a school bus.
- 13 Sec. 49. A driver of a public or nonpublic school bus or
- 14 pupil transportation vehicle shall have in his or her possession
- 15 a certificate stating that he or she has completed a course in
- 16 school bus safety education within the immediately preceding 2
- 17 years. The entry level course and subsequent 6-hour continuing
- 18 education course shall be approved by the superintendent of
- 19 public instruction and shall be provided by an intermediate
- 20 school district or a state university. The cost of the course of
- 21 instruction and the base rate of compensation of the driver
- 22 during the course of instruction shall be reimbursed by the state
- 23 on an equal basis for public and nonpublic schools as provided
- 24 for by the department of education. The certificate of comple-
- 25 tion of each course shall be prescribed by the superintendent of
- 26 public instruction and completed by an instructor of the course.
- 27 Failure to complete the entry level course or the 6-hour

- 1 continuing education course within 2 years after certification of
- 2 completion of a prior course shall be reported by the instruc-
- 3 tional agency to the department of education and to the school
- 4 which employs the bus driver. A driver who fails to complete or
- 5 meet the continuing education requirements shall not be permitted
- 6 to drive a school bus transporting passengers. This section
- 7 shall not be construed to apply to employees or transportation
- 8 equipment operators of commercial bus companies engaged in the
- 9 regular business of carrying passengers for hire.
- 10 Sec. 51. (1) All regular drivers and substitute drivers of
- 11 school buses shall meet the following qualifications:
- 12 (a) The driver shall be in good physical and mental health,
- 13 be able-bodied, free from communicable disease, and strong enough
- 14 physically to handle the bus with ease.
- (b) As evidence of his or her physical fitness and mental
- 16 alertness, the driver shall submit, not less than once each 5
- 17 years, to a physical examination by a reputable physician desig-
- 18 nated by the local board of education, and he or she shall
- 19 present the physician's certificate to the employing school board
- 20 or the superintendent of the school to which the pupils are being
- 21 transported. A superintendent who has reason to believe that a

- 26 with a physician's certificate shall be maintained in the office
- 27 of the local school superintendent. In case of a primary school

- 1 district, the record and certificate shall be filed with the
- 2 intermediate school superintendent on forms prescribed by the
- 3 superintendent of public instruction.
- 4 (2) A person shall not smoke on a school bus within 1 hour
- 5 of the use of the bus by pupils.
- 6 Sec. 53. (1) Except as provided in subsections (2), (3),
- 7 and (4), the driver of a school bus, before crossing a railroad
- 8 track at grade, shall stop the vehicle within 50 feet but not
- 9 less than 10 feet from the nearest rail and while stopped shall
- 10 listen and look in both directions along the track for an
- 11 approaching train and for signals indicating the approach of a
- 12 train, and shall not proceed until the driver can do so safely.
- 13 After stopping as required in this subsection, and upon proceed-
- 14 ing when it is safe to do so, the driver of the vehicle shall
- 15 cross only in a gear of the vehicle that does not require chang-
- 16 ing gears while traversing the crossing. The driver shall not 🐰
- 17 shift gears while crossing the track or tracks.
- (2) A stop need not be made at a railroad track grade cross-
- 19 ing where a police officer or a traffic-control signal directs
- 20 traffic to proceed.
- 21 (3) A stop need not be made at an abandoned railroad track
- 22 grade crossing. As used in this subsection, "abandoned railroad
- 23 track" means a railroad track which meets all of the following
- 24 requirements:
- 25 (i) The track has been abandoned pursuant to Act No. 56 of
- 26 the Public Acts of 1919, being sections 469.241 to 469.246 of the
- 27 Michigan Compiled Laws; section 14 of Act No. 300 of the Public

- 1 Acts of 1909, being section 462.14 of the Michigan Compiled Laws; 2 or federal law.
- 3 (ii) The track has been covered or removed.
- 4 (iii) All signs, signals, and other warning devices are 5 removed.
- 6 (4) A stop shall not be made at a railroad track grade
 7 crossing on a freeway or limited access highway where the cross-
- 8 ing is protected by a clearly visible signal, crossing gate, or
- 9 barrier at a time when the signal, crossing gate, or barrier is 10 not activated.
- (5) A person who violates this section is responsible for a 12 civil infraction.
- 13 Sec. 55. (1) A driver of a school bus shall not transport
 14 or permit to be transported on a school bus while transporting
 15 pupils to and from school a person other than pupils, persons
 16 enrolled in a school-sponsored preschool program authorized by
 17 state or federal statute, teachers, or chaperons of the pupils or
 18 other persons authorized by the local board of education for the
 19 protection of property or the health, safety, and welfare of the
 20 pupils or persons attending other school related functions, or
 21 both. This subsection shall not apply during the transportation
 22 of persons under section 59.
- (2) After the fourth Friday following Labor day of each
 24 school year a school bus shall not be used to transport more than
 25 110% of the number of persons for which the school bus has a

- 1 (3) All school buses transporting pupils shall be equipped
- 2 with first aid kits, fire extinguishers, and traffic flares in a

- 5 (4) A person who violates this section is responsible for a
- 6 civil infraction.
- 7 Sec. 57. A person driving a school bus shall not exceed the
- 8 speed of 55 miles per hour on a limited access highway or freeway
- 9 and 50 miles per hour on any other roadway.
- 10 Sec. 59. (1) Pursuant to an agreement made under subsection
- 11 (4), the board of a school district may permit the use of a
- 12 school bus which is not otherwise being used for school purposes
- 13 by an organization or group for purposes of transporting senior
- 14 citizens or retired or disabled persons to or from an activity,
- 15 event, or outing, if the board determines that suitable or eco-
- 16 nomically feasible public or private transportation is not avail-

- 1 (e) It is determined that other suitable or economical
- 2 transportation is not available.
- 3 (6) A school bus shall be returned in adequate time to be
- 4 properly checked and serviced for its scheduled route
- 5 assignment.
- 6 (7) The state board shall promulgate rules to implement this 7 section.
- 8 Sec. 61. (1) If a determination is made that economically
- 9 feasible private transportation does not exist, the board of a
- 10 local or intermediate school district may contract with a feder-
- 11 al, state, or local unit of government, or a subcontractor of
- 12 these units, for the use of a school bus to transport persons to
- 13 or from an activity or function sponsored or operated by the unit
- 14 of government. The governmental agency, or subcontractors of the
- 15 governmental agency, shall pay the full costs incurred in the use

- 1 Sec. 63. The cost of purchasing pupil transportation
- 2 vehicles and school buses and the rehabilitation of school buses
- 3 to extend the period of usefulness shall conform with the rules
- 4 promulgated by the department of education to provide state aid
- 5 to eligible school districts for the purchase of pupil transpor-
- 6 tation vehicles and school buses and the cost of rehabilitation
- 7 of school buses to extend the period of usefulness.
- 8 Sec. 65. (1) A person who violates this act is guilty of a
- 9 misdemeanor, unless that violation is by this act or other law of
- 10 this state declared to be a felony or a civil infraction.
- (2) Unless another penalty is provided in this act or by the
- 12 laws of this state, a person convicted of a misdemeanor for the
- 13 violation of this act shall be punished by a fine of not more
- 14 than \$500.00, or by imprisonment for not more than 3 months, or
- 15 both.
