## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 280 of the Public Acts of 1939, as

- 3 Laws, is amended by adding section 123 to read as follows:
- 4 SEC. 123. (1) EXCEPT AS PROVIDED IN SUBSECTION (2) OR (3),
- 5 AN INDIVIDUAL WHO HAS BEEN CONVICTED OF A FELONY, OR WHO IS
- 6 SUBJECT TO ANY PENDING FELONY CHARGES, SHALL NOT BE EMPLOYED OR
- 7 APPOINTED TO SERVE IN A POSITION IN THE STATE DEPARTMENT, DEALING
- 8 DIRECTLY WITH CHILDREN AND YOUTH SERVICES, INCLUDING, BUT NOT

- 1 LIMITED TO, ABUSE, NEGLECT, DETENTION, FOSTER CARE, ADOPTION, AND 2 PROBATION.
- 3 (2) THE DIRECTOR MAY WAIVE THE PROHIBITION IN SUBSECTION (1)
- 4 AS TO AN INDIVIDUAL WHO HAS BEEN CONVICTED OF A FELONY. AND WHO
- 5 MEETS BOTH OF THE FOLLOWING CONDITIONS:
- 6 (A) THE DATE OF FINAL RELEASE FROM INCARCERATION, THE DATE
- 7 OF FINAL RELEASE FROM PROBATION, OR THE DATE OF FINAL RELEASE

- 12 (B) THE DIRECTOR CONDUCTS AN EXTENSIVE AND COMPLETE INVESTI-
- 13 GATION OF THE INDIVIDUAL'S BACKGROUND, AND DETERMINES THAT, NOT-
- 14 WITHSTANDING THE INDIVIDUAL'S FELONY CONVICTION, THE EMPLOYMENT
- 15 OR APPOINTMENT OF THE INDIVIDUAL IS APPROPRIATE. A WRITTEN
- 16 REPORT, SIGNED BY THE DIRECTOR, SHALL BE MADE OF EVERY INVESTIGA-
