## SENATE BILL No. 584

A bill to amend Act No. 368 of the Public Acts of 1978, entitled as amended

"Public health code,"

as amended, being sections 333.1101 to 333.25211 of the Michigan Compiled Laws, by adding sections 21541 and 21542; and to repeal certain parts of the act on a specific date.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 5 SEC. 21541. (1) SUBJECT TO SUBSECTION (4), A TEACHING HOS-

- 1 WORK MORE THAN AN AVERAGE OF 80 HOURS PER WEEK OVER A CONSECUTIVE
- 2 4-WEEK PERIOD. A HOSPITAL SHALL NOT SCHEDULE A RESIDENT PHYSI-
- 3 CIAN DESCRIBED IN THIS SUBSECTION TO WORK MORE THAN 1 CONSECUTIVE
- 4 24-HOUR PERIOD PER WEEK. IF A HOSPITAL DOES SCHEDULE A RESIDENT
- 5 PHYSICIAN TO WORK A CONSECUTIVE 24-HOUR PERIOD, THEN THE HOSPITAL
- 6 SHALL ALSO SCHEDULE THE RESIDENT PHYSICIAN IN THE SAME WEEK TO
- 7 NOT WORK FOR A CONSECUTIVE 24-HOUR PERIOD.
- 8 (2) A HOSPITAL DESCRIBED IN SUBSECTION (1) SHALL DEVELOP A

- 21 (G) A SERVICE, OTHER THAN THOSE LISTED IN SUBDIVISIONS (A)
- 22 TO (F) AND EMERGENCY SERVICES, WITH HIGH PATIENT TURNOVER OR
- 23 ACUTELY ILL PATIENTS, OR BOTH.
- 24 (4) SUBSECTION (1) DOES NOT APPLY TO SERVICES, OTHER THAN
- 25 THOSE LISTED IN SUBSECTION (3) AND EMERGENCY SERVICES, IN WHICH
- 26 THE RESIDENT PHYSICIANS GET ADEQUATE PERIODS OF REST INCLUDING,

- 5 PROVIDES SERVICES TO MORE THAN 15,000 PATIENTS PER YEAR AND
- 6 ADMITS RESIDENT PHYSICIANS TO PRACTICE SHALL NOT SCHEDULE A RESI-
- 7 DENT PHYSICIAN TO WORK IN THE EMERGENCY ROOM OR DEPARTMENT MORE
- 8 THAN 1 CONSECUTIVE 12-HOUR PERIOD PER ROTATION.
- 9 (6) IF A RESIDENT PHYSICIAN HAS WORKED A CONSECUTIVE 24-HOUR
- 10 PERIOD AS DESCRIBED IN SUBSECTION (1) OR A CONSECUTIVE 12-HOUR
- 11 PERIOD AS DESCRIBED IN SUBSECTION (5), ANOTHER HOSPITAL SHALL NOT
- 12 SCHEDULE THE RESIDENT PHYSICIAN TO WORK A CONSECUTIVE PERIOD IN
- 13 VIOLATION OF SUBSECTION (1) OR (5).
- 14 (7) EACH HOSPITAL THAT ADMITS RESIDENT PHYSICIANS TO PRAC-
- 15 TICE SHALL HAVE AVAILABLE AT ALL TIMES INTRAVENOUS SERVICES,
- 16 PHLEBOTOMY SERVICES. AND MESSENGER AND TRANSPORTATION SERVICES
- 17 SUFFICIENT TO MEET REASONABLE AND EXPECTED DEMANDS.
- 18 (8) THE DEPARTMENT MAY PROMULGATE RULES TO IMPLEMENT THIS
- 19 SECTION.
- 20 SEC. 21542. (1) THE TASK FORCE ON HOSPITAL MANAGEMENT AND
- 21 PHYSICIAN RESIDENT EDUCATION IS CREATED IN THE DEPARTMENT. THE
- 22 TASK FORCE SHALL CONSIST OF 15 MEMBERS APPOINTED BY THE GOVERNOR
- 23 WITH THE ADVICE AND CONSENT OF THE SENATE AS FOLLOWS:
- 24 (A) EIGHT MEMBERS SHALL BE PHYSICIANS, 4 OF WHOM SHALL BE
- 25 RESIDENT PHYSICIANS.
- 26 (B) FOUR MEMBERS SHALL BE REPRESENTATIVE OF HOSPITALS.

- (C) THREE MEMBERS SHALL BE REPRESENTATIVE OF THE INSURANCE 2 INDUSTRY.
- 3 (2) THE MEMBERS OF THE TASK FORCE SHALL SERVE FOR A TERM OF
- 4 3 YEARS. A VACANCY ON THE TASK FORCE SHALL BE FILLED IN THE SAME
- 5 MANNER AS THE ORIGINAL APPOINTMENT FOR THE BALANCE OF THE UNEX-
- 6 PIRED TERM.
- 7 (3) THE TASK FORCE SHALL DO ALL OF THE FOLLOWING:
- 8 (A) FILE AN ANNUAL REPORT ON THE OPERATION OF SECTION 2:541
- 9 WITH THE SENATE AND HOUSE COMMITTEES WITH JURISDICTION OVER MAT-
- 10 TERS PERTAINING TO PUBLIC HEALTH.
- 11 (B) RECOMMEND TO THE DEPARTMENT CHANGES TO THE REQUIREMENTS
- 12 OF SECTION 21541, IF CHANGES ARE CONSIDERED NECESSARY BY THE TASK
- 13 FORCE.
- 14 (4) THE DEPARTMENT MAY MODIFY THE REQUIREMENTS OF
- 15 SECTION 21541 BY PROMULGATING RULES TO EFFECTUATE THE RECOMMENDA-
- 16 TIONS OF THE TASK FORCE MADE UNDER SUBSECTION (3).
- 17 (5) THIS SECTION IS REPEALED EFFECTIVE UPON THE EXPIRATION
- 18 OF 4 YEARS AFTER ITS EFFECTIVE DATE.
