## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Sections 1289 and 1521 of Act No. 451 of the
- 2 Public Acts of 1976, being sections 380.1289 and 380.1521 of the
- 3 Michigan Compiled Laws, are amended to read as follows:
- 4 Sec. 1289. (1) -A- EXCEPT AS OTHERWISE PROVIDED IN THIS
- 5 SUBSECTION, A board of a school district may join an organi-
- 6 zation, association, or league -which- THAT has as its object the
- 7 promotion and regulation of sport and athletic, oratorical,
- 8 musical, dramatic, creative arts, or other contests by or between
- 9 pupils if the organization, association, or league provides in

- 1 its constitution or bylaws that a representative of the state
- 2 board shall be an ex officio member of its governing body with
- 3 the same rights and privileges as other members of its governing
- 4 body. A BOARD OF A SCHOOL DISTRICT SHALL NOT JOIN OR BELONG TO
- 5 AN ORGANIZATION, ASSOCIATION, OR LEAGUE THAT HAS A MAXIMUM AGE

- 8 (2) The association CREATED PURSUANT TO SECTION 1289 THAT
- 9 HAS THE OBJECT DESCRIBED IN SUBSECTION (1) is the official asso-
- 10 ciation of the state for the purpose of organizing and conducting
- 11 athletic events, contests, and tournaments among schools. The
- 12 association shall be responsible for the adoption and enforcement

- 14 participation in interscholastic athletic events, contests, and
