

SENATE BILL No. 696

November 28, 1989, Introduced by Senator DILLINGHAM
and referred to the Committee on State Affairs,
Tourism, and Transportation.

A bill to amend sections 3 and 43 of Act No. 152 of the
Public Acts of 1979, entitled as amended
"State license fee act,"
as amended by Act No. 461 of the Public Acts of 1988, being sec-
tions 338.2203 and 338.2243 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Sections 3 and 43 of Act No. 152 of the Public
2 Acts of 1979, as amended by Act No. 461 of the Public Acts of
3 1988, being sections 338.2203 and 338.2243 of the Michigan
4 Compiled Laws, are amended to read as follows:

5 Sec. 3. (1) The fees prescribed by this act shall be used
6 only to offset the cost of operating the department.

7 (2) ~~The~~ EXCEPT AS OTHERWISE PROVIDED IN SECTION 43, THE
8 fees collected pursuant to this act shall be credited to the
9 general fund of the state.

1 Sec. 43. (1) Fees for a person licensed or seeking
 2 licensure to engage in the practice of mortuary science or to
 3 operate a funeral establishment or for a person licensed or seek-
 4 ing licensure as a resident trainee, or licensed as an embalmer
 5 or funeral director under article 18 of the occupational code,
 6 being sections 339.1801 to 339.1812 of the Michigan Compiled
 7 Laws, are as follows:

8 (a) Application processing fees:

9 (i) Mortuary science license.....\$ 20.00
 10 (ii) Funeral establishment license..... 115.00
 11 (iii) Resident trainee..... 15.00

12 (b) Examination fees:

13 (i) Complete examination..... 200.00
 14 (ii) National examination only..... 150.00
 15 (iii) State examination only..... 50.00

16 (c) Examination review..... 25.00

17 (d) License fees, per year:

18 (i) Mortuary science..... ~~30.00~~ 35.00
 19 (ii) Funeral establishment..... ~~55.00~~ 60.00
 20 (iii) Embalmer..... ~~30.00~~ 35.00
 21 (iv) Funeral director..... ~~30.00~~ 35.00
 22 (v) Resident trainee..... 15.00

23 (2) THE \$5.00 FEE INCREASE RESULTING FROM THE AMENDATORY ACT
 24 THAT ADDED THIS SUBSECTION SHALL BE DEPOSITED INTO THE MORTUARY
 25 SCIENCE EDUCATION FUND CREATED IN SECTION 1806B OF THE OCCUPA-
 26 TIONAL CODE, BEING SECTION 339.1806B OF THE MICHIGAN COMPILED
 27 LAWS, AND USED IN THE MANNER PROVIDED FOR IN THAT SECTION.
