

SENATE BILL No. 722

December 12, 1989, Introduced by Senators FESSLER, O'BRIEN, GEO. HART, BINSFELD and FREDRICKS and referred to the Committee on Judiciary.

A bill to amend section 356a of Act No. 328 of the Public Acts of 1931, entitled
"The Michigan penal code,"
being section 750.356a of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 356a of Act No. 328 of the Public Acts
2 of 1931, being section 750.356a of the Michigan Compiled Laws, is
3 amended to read as follows:

4 Sec. 356a. (1) ~~Any~~ A person who ~~shall commit~~ COMMITS
5 the offense of larceny by stealing or unlawfully removing or
