"An act to provide for the incorporation of villages; to define their powers and duties; to provide for the levy and collection of taxes, borrowing of money, and issuance of bonds and other

evidences of indebtedness by villages; to define the powers and duties of the municipal finance commission or its successor agency and of the department of treasury with regard thereto; to define the application of this act and provide for its amendment by villages subject thereto; and to validate prior amendments and certain prior actions taken and bonds issued by villages,"

as amended by Act No. 205 of the Public Acts of 1983, being section 65.5 of the Michigan Compiled Laws.

- (1) The council shall prescribe the rules of its 2 Sec. 5. own proceedings, and shall keep a record of those proceedings. Α 3 majority of the members -shall be CONSTITUTES a quorum for the 4 transaction of business. A lesser number may adjourn and compel 5 the attendance of absent members in a manner -as- prescribed by 6 7 ordinance.
