THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 5 Sec. 5. (1) "Health officer" means a full-time administra-
- 6 tive officer of a certified city, county, or district department

- 8 (2) "HOUSEHOLD" MEANS A SINGLE DETACHED DWELLING UNIT OR A
- 9 SINGLE UNIT OF A MULTIPLE DWELLING.

- 1 (3) -(2) "Inert material" means a substance that will not
- 2 decompose, dissolve, or in any other way form a contaminated
- 3 leachate upon contact with water, or other liquids determined by
- 4 the director as likely to be found at the disposal area, perco-
- 5 lating through the substance.
- 6 (4) "INFECTIOUS AGENT" MEANS AN ORGANISM, SUCH AS A VIRUS OR
- 7 BACTERIUM, THAT IS CAPABLE OF BEING COMMUNICATED BY INVASION AND
- 8 MULTIPLICATION IN BODY TISSUES AND CAPABLE OF CAUSING DISEASE OR
- 9 ADVERSE HEALTH IMPACTS IN HUMANS.
- 10 (5) -(3) "Landfill" means a disposal area that is a sani-

- 15 (i) CULTURES AND STOCKS OF INFECTIOUS AGENTS AND ASSOCIATED
- 16 BIOLOGICALS, INCLUDING LABORATORY WASTE, BIOLOGICAL PRODUCTION
- 17 WASTES, DISCARDED LIVE AND ATTENUATED VACCINES, CULTURE DISHES,
- 18 AND RELATED DEVICES.
- 19 (ii) LIQUID HUMAN AND ANIMAL WASTE, INCLUDING BLOOD AND
- 20 BLOOD PRODUCTS AND BODY FLUIDS, BUT NOT INCLUDING URINE OR MATE-
- 21 RIALS STAINED WITH BLOOD OR BODY FLUIDS.
- 22 (iii) PATHOLOGICAL WASTE.
- (iv) SHARPS.
- 24 (v) CONTAMINATED WASTES FROM ANIMALS THAT HAVE BEEN EXPOSED
- 25 TO AGENTS INFECTIOUS TO HUMANS, THESE BEING PRIMARILY RESEARCH
- 26 ANIMALS.

- 1 (7) -(4) "Municipal solid waste incinerator" means an
- 2 incinerator that is owned or operated by any person, and meets
- 3 all of the following requirements:
- 4 (a) The incinerator receives solid waste from off site and
- 5 burns only household waste from single and multiple dwellings,
- 6 hotels, motels, and other residential sources, or this household
- 7 waste together with solid waste from commercial, institutional,
- 8 municipal, county, or industrial sources that, if disposed of,
- 9 would not be required to be placed in a disposal facility
- 10 licensed under the hazardous waste management act, Act No. 64 of
- 11 the Public Acts of 1979, being sections 299.501 to 299.551 of the
- 12 Michigan Compiled Laws.
- 13 (b) The incinerator has established contractual requirements
- 14 or other notification or inspection procedures sufficient to
- 15 assure that the incinerator receives and burns only waste
- 16 referred to in subdivision (a).
- 17 (c) The incinerator meets the requirements of this act and
- 18 the rules promulgated under this act.
- (d) The incinerator is not an industrial furnace as defined
- 20 in 40 C.F.R. 260.10.
- 21 (E) THE INCINERATOR IS NOT AN INCINERATOR THAT RECEIVES AND
- 22 BURNS ONLY MEDICAL WASTE OR WASTE PRODUCED AT 1 OR MORE
- 23 HOSPITALS.
- 24 (8) -(5) "Municipal solid waste incinerator ash" means the
- 25 substances remaining after combustion in a municipal solid waste
- 26 incinerator.

- 1 (9) -(6) "Municipality" means a city, township, or
- 2 village.
- 3 (7) "Perpetual care trust fund" means a perpetual care
- 4 trust fund provided for in-section 19b.
- 5 (10) -(8)- "Person" means an individual; sole proprietor-
- 6 ship; partnership; association; corporation, public or private,
- 7 organized or existing under the laws of this state or any other
- 8 state, including a federal corporation; this state or an agency
- 9 or department of this state; a municipality in this state; or a
- 10 county in this state.
