- 1 HAVING, ALZHEIMER'S DISEASE OR A RELATED DISORDER. THIS SECTION
- 2 DOES NOT APPLY TO SERVICE-SPECIFIC CERTIFICATES.
- 3 (2) AS USED IN THIS SECTION:
- 4 (A) "RELATED DISORDER" MEANS AN IRREVERSIBLE BRAIN DISORDER
- 5 THAT RESULTS IN THE MANIFESTATIONS OF SYMPTOMS AND SIGNS INCLUD-
- 6 ING, BUT NOT LIMITED TO, MEMORY LOSS, APHASIA, BECOMING LOST OR
- 7 DISORIENTED, CONFUSION, AND AGITATION WITH THE POTENTIAL FOR COM-
- 8 BATIVENESS AND INCONTINENCE. RELATED DISORDER INCLUDES, BUT IS
- 9 NOT LIMITED TO, MULTI-INFARCT DEMENTIA, HUNTINGTON'S DISEASE, AND

- 11 (B) "SERVICE-SPECIFIC CERTIFICATE" MEANS A GROUP OR NONGROUP
- 12 CERTIFICATE PROVIDING COVERAGE SOLELY FOR 1 OF THE FOLLOWING:
- 13 DENTAL CARE, HEARING CARE, VISION CARE, PRESCRIPTION DRUGS, OR
- 14 ANOTHER SPECIFIC TYPE OF HEALTH CARE BENEFIT.
