

SENATE BILL No. 110

February 7, 1989, Introduced by Senator WELBORN and referred to the Committee on Criminal Justice and Urban Affairs.

A bill to amend sections 325, 326, and 327 of Act No. 380 of the Public Acts of 1965, entitled "Executive organization act of 1965," being sections 16.425, 16.426, and 16.427 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Sections 325, 326, and 327 of Act No. 380 of the
2 Public Acts of 1965, being sections 16.425, 16.426, and 16.427 of
3 the Michigan Compiled Laws, are amended to read as follows:
