- 1 with intent to defraud the owner thereof, or who having procured
- 2 or taken any such book, pamphlet, map, chart, painting, picture,
- 3 photograph, periodical, newspaper, magazine, manuscript or

- 5 his own use or fraudulently deprive the owner thereof, shall be
- 6 quilty of a misdemeanor.

- 16 (2) A PERSON WHO VIOLATES SUBSECTION (1) IS GUILTY OF A MIS-
- 17 DEMEANOR, PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 90 DAYS,
- 18 OR BY A FINE OF NOT MORE THAN \$100.00, OR BOTH.
