Health facilities; nursing homes; medicaid participating facilities; require to have one waiting list for all applicants and to admit applicants in the order in which they apply, subject to certain exceptions. Amends Act 368 of 1978 (MCL 333.1101 - 333.25211) by adding sec. 21762.
