HB 5788 - Bryant

Categories: Food, Sales & use tax

Sales tax; collections; certain take-out home delivered foods; include as taxable. Amends sec. 4g of Act 167 of 1933 (MCL 205.54g). 4-30-92 (HJ 53 p 1018) Committee on Taxation ★★★

HB 5789 - Keith (same as SB 768)

Categories: Education

Education; attendance; 180 full days of school; require. Amends sec. 1284 of Act 451 of 1976 (MCL 380.1284). 4-30-92 (HJ 53 p 1018) Committee on Education ★★★

HB 5790 - Keith (same as SB 769)

Categories: Education, Schools

Education; attendance; 180 days requirement for state school aid; specify as requiring 180 full days. Amends sec. 101 of Act 94 of 1979 (MCL 388.1701). 4-30-92 (HJ 53 p 1018) Committee on Education ★★★

HB 5791 - Griffin (same as SB 868)

Categories: Energy, Public utilities

Public utilities; public service commission; utility purchases of energy or capacity from an affiliate; require to be competitively priced. Amends sec. 6j of Act 3 of 1939 (MCL 460.6j). 4-30-92 (HJ 53 p 1018) Committee on Public Utilities ★★★

HB 5792 - Hertel

Categories: Civil procedure, Liens, Property, Property tax

Property tax; tax sales; certain abandoned residential property; revise foreclosure process. Amends secs. 57, 60, 61, 73c, 74, 108, 131, 131c & 131e of Act 206 of 1893 (MCL 211.57 et seq.) & adds sec. 55a. 4-30-92 (HJ 53 p 1018) Committee on Taxation ★★★ 6-4-92 (HJ 72 p 1419) second reading with substitute (H-3) ★★★ 6-10-92 (HJ 74 p 1531) third reading with substitute (H-3), passed ★★★ 6-25-92 (SJ 59 p 1784) COMMITTEE ON FINANCE ★★★

Categories: Environmental protection, State agencies & departments

HB 5795 - Porreca

Categories: Highways, Local government, Mobile homes

Mobile homes; parks; mobile home parks; require snow removal from streets. Amends Act 96 of 1987 (MCL 125.2301 - 125.2349) by adding sec. 2328d. 4-30-92 (HJ 53 p 1019) Committee on Transportation ★★★

HB 5796 - Keith (same as SB 907)

Categories: Transportation

Transportation; funds; distribution; allow certain eligible governmental agencies to directly receive state operating assistance from the eligible authority in their service area. Amends sec. 10 of Act 204 of 1967 (MCL 124.410). 4-30-92 (HJ 53 p 1019) Committee on Transportation ★★★

HB 5797 - Baade

Categories: Motor vehicles, Occupations, Safety, Trade

Vehicles; equipment; penalties for certain businesses that put illegal coverings on car windows; establish. Amends sec. 709 of Act 300 of 1949 (MCL 257.709). 4-30-92 (HJ 53 p 1019) Committee on Transportation ★★★

HB 5798 - O'Connor

Categories: Construction, State agencies & departments

Construction; contracts; certain road and bridge contractors; require to guarantee for 5 years. Amends Act 51 of 1951 (MCL 247.651 - 247.675) by adding sec. 11e. 4-30-92 (HJ 53 p 1019) Committee on Transportation ★★★

HB 5799 - Dresch

Categories: Controlled substances, Crimes

Controlled substances; other; simple possession of controlled substance analogue; prohibit under certain circumstances. Amends sec. 7403 of Act 368 of 1978 (MCL 333.7403). 4-30-92 (HJ 53 p 1018) Committee on Judiciary ★★★

HB 5800 - Bryant

Categories: Education, Health

Health; smoking; smoking in public school buildings; prohibit. Amends secs. 12801, 12811 & 12813 of Act 368 of 1978 (MCL 333.12801 et seq.) & adds sec. 12804b. 4-30-92 (HJ 53 p 1019) Committee on Education ★★★
