Categories: Counties, Land use

**HB 6027 - Alley**

Categories: Counties, Highways

Counties; boards and commissions; road commission; increase size of board. Amends secs. 6 & 7, ch. IV of Act 283 of 1909 (MCL 224.6 & 224.7). 7-22-92 (HJ 79 p 2032) Committee on Towns & Counties ★★

**HB 6028 - Alley**

Categories: Counties, Elections, Highways

Elections; local; county road commissioner; increase size of board. Amends secs. 255, 257, 258, 261, 262, 263 & 264 of Act 116 of 1954 (MCL 168.255 et seq.). 7-22-92 (HJ 79 p 2032) Committee on Towns & Counties ★★

**HB 6029 - Power**

Categories: Civil procedure, Occupations

Civil procedure; costs and fees; attorney fees in civil lawsuit; require losing party to pay for winning party. Amends Act 236 of 1961 (MCL 600.101 - 600.9947) by adding sec. 2421h. 7-22-92 (HJ 79 p 2032) Committee on Judiciary ★★

**HB 6030 - Kosteva**

Categories: Libraries

Libraries; local; certain city, village, and township libraries; authorize to acquire property, construct buildings, and issue bonds. Amends title of Act 164 of 1877 (MCL 397.201 - 397.217) & adds secs. 18, 19, 20, 21 & 22. 7-22-92 (HJ 79 p 2032) Committee on Taxation ★★

**HB 6031 - Randall**

Categories: Construction, Occupations, State agencies &amp; departments

Occupations; other; the imposition and disposition of certain license fees; provide for. Amends title & sec. 8 of Act 333 of 1976 (MCL 338.2158). 7-22-92 (HJ 79 p 2032) Committee on Labor ★★

**HB 6032 - Randall**

Categories: Construction, Occupations, State agencies &amp; departments

Occupations; other; imposition and disposition of certain fees relating to activities involving elevators; provide for. Amends title & secs. 8 & 16 of Act 227 of 1967 (MCL 408.808 & 408.816) & adds sec. 16a. 7-22-92 (HJ 79 p 2033) Committee on Labor ★★

**HB 6033 - Bennane**

Categories: Domestic relations, Education, Occupations, State agencies &amp; departments

Domestic relations; child support; failure of certain individuals to pay child support; provide for action against license. Amends Act 451 of 1976 (MCL 380.1 - 380.1852) by adding secs. 1535b & 1539c. 7-22-92 (HJ 79 p 2033) Committee on Judiciary ★★

**HB 6034 - W. Bullard**

Categories: Insurance, Motor vehicles

Insurance; no-fault; Michigan catastrophic claims association fees; provide single fee for persons owning multiple motorcycles. Amends sec. 3104 of Act 218 of 1956 (MCL 500.3104). 7-22-92 (HJ 79 p 2033) Committee on Insurance ★★

**HB 6035 - W. Bullard**

Categories: Cities, Labor, Parks &amp; recreation, Townships, Villages

Labor; other; employment of minors at least 11 years of age; allow for scorekeepers, referees, umpires, and recreational employees employed by a township, village, or city recreation department. Amends sec. 3 of Act 90 of 1978 (MCL 409.103). 7-22-92 (HJ 79 p 2033) Committee on Labor ★★

**HB 6036 - Sikkema**

Categories: Education, Sales &amp; use tax

Sales tax; exemptions; products sold for fund-raising by certain educational foundation; exempt. Amends Act 167 of 1933 (MCL 205.51 - 205.78) by adding sec. 4n. 7-22-92 (HJ 79 p 2033) Committee on Taxation ★★

**HB 6037 - Byrum**

Categories: Counties, Highways, State agencies &amp; departments

Highways; funds; use of highway funds by counties for maintenance; allow to include turn lanes in certain rural areas and small communities. Amends sec. 12 of Act 51 of 1951 (MCL 247.682). 7-22-92 (HJ 79 p 2033) Committee on Transportation ★★

**HB 6038 - Byrum**

Categories: Civil procedure, Courts, Crimes

Civil procedure; injunctions; injunction to prohibit an individual from stalking another individual; allow circuit court to issue under certain circumstances. Amends sec. 15b, ch. IV & sec. 2, ch. XI of Act 175 of 1927 (MCL 764.15b & 771.2) & adds sec. 2a to ch.
