Categories: Consumer credit & protection, Financial institutions

Consumer credit and protection; other; credit card and social security number; prohibit merchants from requesting as a condition of acceptance of personal checks. Amends Act 328 of 1931 (MCL 750.1 - 750.568) by adding sec. 95b.

Categories: Motor vehicles, Sales & use tax, State agencies & departments

Use tax; exemptions; sale of vehicle that qualifies for family member exemption; require secretary of state to obtain affidavit and forward to department of treasury. Amends sec. 3 of Act 94 of 1937 (MCL 205.93).

Local government; bonds; health and safety fund distributions; permit county to pledge for payment of bonds for jail facilities. Amends secs. 2 & 6 of Act 264 of 1987 (MCL 141.472 & 141.476) & adds sec. 5a.

Categories: Corrections, Counties, Criminal procedure
Criminal procedure; sentencing; imprisonment or probation for crimes punishable by 2 years or less; allow to be made to county facilities under certain circumstances. Amends sec. 28, ch. IX & sec. 3, ch. XI of Act 175 of 1927 (MCL 769.28 & 771.3).
