Categories: Insurance

Insurance; health care corporations; in vitro fertilization services; require offer to provide coverage for. Amends Act 350 of 1980 (MCL 550.1101 - 550.1704) by adding sec. 416b.

Categories: Employment security

Employment security; employers; common paymaster rule; allow Michigan employers to use based on federal law. Amends sec. 44 of Act 1 of Ex. Sess. 1936 (MCL 421.44).

### HB 4712 - Bender

Categories: Corrections, Health

Corrections; parole; inmate infected with AIDS or other sexually communicable disease; require parole board to consider as criteria for parole whether the prisoner informed those who may have been exposed to the disease. Amends sec. 35 of Act 232 of 1953 (MCL 791.235) & adds sec. 33c.

Categories: Sales & use tax, Taxation

Sales tax; definitions; cigarette tax included in gross proceeds; provide for. Amends sec. 1 of Act 167 of 1933 (MCL 205.51).

Categories: Taxation

Taxation; tobacco; excise tax on noncigarette tobacco products; establish.

Single business tax; deductions; capital acquisition deduction; revise. Amends sec. 23 of Act 228 of 1975 (MCL 208.23).

Categories: Education, State agencies & departments

Education; school districts; requests for property transfers; require state board of education to take into account certain factors, create appeals board, and change appeals procedure. Amends sec. 605 & 953 of Act 451 of 1976 (MCL 380.605 & 380.953); adds sec. 972 & repeals sec. 971 of Act 451 of 1976 (MCL 380.971).
