Categories: Property tax  
Property tax; tax tribunal; the use of a model in assessment appeals; provide requirements, require certain materials to be made available to support estimate of true cash value, and provide procedural requirements. Amends secs. 44 & 46 of Act 186 of 1973 (MCL 205.744 & 205.746) & adds sec. 35a.

Categories: Crimes, Criminal procedure  
Crimes; obscenity; possession or dissemination of certain obscene materials; prohibit based upon customary limits of vicinage from which jury is drawn, and regulate introduction of certain evidence. Amends title & secs. 2, 5 & 7 of Act 343 of 1984 (MCL 752.362 et seq.); adds secs. 6a, 6b & 6c & repeals secs. 6, 11, 12 & 13 of Act 343 of 1984 (MCL 752.366 et seq.).
