Crimes; victims; release of names of criminal sexual assault victims; prohibit under certain circumstances and establish procedure for victim to use pseudonym. Amends ch. XVI of Act 175 of 1927 (MCL 776.6 - 776.21) by adding secs. 22, 23 & 24.
