Labor; health and safety; MIOSHA; provide for transfer of money from the SET fund to the state general fund for the operation of MIOSHA programs, beginning April 1, 1992 require that state safety and health rules be substantially similar to federal OSHA standards, increase number of commissioner votes required to promulgate a standard, increase certain civil penalties for violation of the act, and provide that civil penalties be assessed consistent with federal assessment.
