The act cut DSH payments by \$10.4 billion from Fiscal Year 1998 to Fiscal Year 2002. Whereas, The shortfall of DSH funding is a major threat to an entire segment of our health care system. With Michigan home to approximately 1 million of the country's 35 million uninsured people, the large cut of DSH funding would seriously impact our state's citizens and the safety net hospitals that serve them; and

Whereas, There are bills before Congress to preserve DSH funding at current fiscal year levels—which already present a genuine financial challenge—rather than implement the more severe cuts scheduled to take place under the Balanced Budget Act of 1997.
