A bill to amend 1980 PA 350, entitled

"The nonprofit health care corporation reform act,"

(MCL 550.1101 to 550.1704) by adding section 416b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 416B. (1) ON AND AFTER JANUARY 1, 2000, EACH GROUP
- 2 CERTIFICATE THAT COVERS 10 OR MORE MEMBERS AND PROVIDES
- 3 PREGNANCY-RELATED COVERAGE SHALL PROVIDE BENEFITS FOR THE DIAGNO-
- 4 SIS AND TREATMENT OF INFERTILITY, INCLUDING, BUT NOT LIMITED TO,
- 5 IN VITRO FERTILIZATION, EMBRYO TRANSFER, ARTIFICIAL INSEMINATION,
- 6 GAMETE INTRAFALLOPIAN TUBE TRANSFER, ZYGOTE INTRAFALLOPIAN TUBE
- 7 TRANSFER, AND INTRACYTOPLASMIC SPERM INJECTION.
- 8 (2) COVERAGE UNDER SUBSECTION (1) FOR PROCEDURES FOR IN
- 9 VITRO FERTILIZATION, GAMETE INTRAFALLOPIAN TUBE TRANSFER, OR
- 10 ZYGOTE INTRAFALLOPIAN TUBE TRANSFER IS REQUIRED ONLY IF ALL OF

- 1 (A) THE MEMBER HAS BEEN UNABLE TO ATTAIN OR SUSTAIN A
- 2 SUCCESSFUL PREGNANCY THROUGH REASONABLE, LESS COSTLY MEDICALLY
- 3 APPROPRIATE INFERTILITY TREATMENTS FOR WHICH COVERAGE IS AVAIL-

- 5 (B) THE MEMBER HAS NOT UNDERGONE 3 OR MORE COMPLETED OOCYTE

- 15 RELIGIOUS INSTITUTION OR ORGANIZATION OR TO AN ENTITY SPONSORED
- 16 BY A RELIGIOUS INSTITUTION OR ORGANIZATION THAT FINDS THE PROCE-
- 17 DURES REQUIRED TO BE COVERED UNDER THIS SECTION TO VIOLATE ITS
- 18 RELIGIOUS AND MORAL TEACHINGS AND BELIEFS.
- 19 (4) AS USED IN THIS SECTION, "INFERTILITY" MEANS THE INABIL-
- 20 ITY TO CONCEIVE AFTER 1 YEAR OF UNPROTECTED SEXUAL INTERCOURSE OR
- 21 THE INABILITY TO SUSTAIN A SUCCESSFUL PREGNANCY.
