SEC. 9163. (1) THE DEPARTMENT, IN CONSULTATION WITH APPRO PRIATE PROFESSIONAL ORGANIZATIONS, SHALL PREPARE PAMPHLETS ON THE
 IMPORTANCE AND TYPES OF SCREENINGS FOR OSTEOPOROSIS AND CERVICAL
 AND PROSTATE CANCERS. THE PAMPHLETS SHALL BE IN ENGLISH,
 SPANISH, AND OTHER LANGUAGES AS DETERMINED APPROPRIATE BY THE
 DEPARTMENT AND SHALL BE IN EASILY UNDERSTOOD, NONTECHNICAL
 TERMS.
