- 3 EXPENSE-INCURRED HOSPITAL, MEDICAL, OR SURGICAL POLICY OR CERTIF-
- 4 ICATE AND A HEALTH MAINTENANCE ORGANIZATION THAT ISSUES OR RENEWS
- 5 A GROUP OR INDIVIDUAL CONTRACT ON OR AFTER JANUARY 1, 2002 SHALL
- 6 PROVIDE FOR BOTH OF THE FOLLOWING:
- 7 (A) THAT COST-SHARING REQUIREMENTS AND BENEFIT OR SERVICE
- 8 LIMITATIONS FOR OUTPATIENT MENTAL HEALTH AND OUTPATIENT SUBSTANCE
- 9 ABUSE SERVICES DO NOT PLACE A GREATER FINANCIAL BURDEN ON THE
- 10 INSURED OR ENROLLEE AND ARE NOT MORE RESTRICTIVE THAN THOSE
- 11 REQUIREMENTS AND LIMITATIONS FOR OUTPATIENT MEDICAL SERVICES.
