by amending sections 1801 and 1810 (MCL 339.1801 and 339.1810), section 1810 as amended by 1990 PA 15.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 1801. As used in this article:

- (a) "Funeral establishment" means a place of business used in the care and preparation for burial or transportation of a dead human body τ or a place where a person represents that the person is engaged in the profession of undertaking or the practice of mortuary science.
 - (b) "Holder of a license for the practice of mortuary science"

- 1 means a person who satisfactorily completes a course in mortuary
- 2 science, who passes an examination prescribed in this article,
- 3 serves the required resident training, and is issued a license for

- 5 (c) "Practice of embalming" means the disinfecting or
- 6 preserving of a dead human body, entirely or in part, by the use of
- 7 a chemical substance, fluid, or gas in the body or by the

- (f) "Resident trainee" means a person who is engaged in

- 24 practice of mortuary science under the instruction and personal
- 25 supervision of a holder of a license for the practice of mortuary

- 27 Sec. 1810. (1) A person shall be subject to the penalties of

- 1 article 6 if the person commits 1 of the following:
- 2 (a) Solicitation of a dead human body by a licensed person or
- 3 an agent, assistant, representative, employee, or a person acting
- 4 on behalf and with the knowledge and consent, express or implied,
- 5 of the licensed person, whether the solicitation occurs after death
- 6 or while death is impending; or the procuring or allowing directly
- 7 or indirectly of a person to call upon an institution or individual
- 8 by whose influence a dead human body may be turned over to the
- 9 licensed person or funeral establishment.
- 10 (b) Procuring a person known as capper, steerer, or solicitor
- 11 to obtain funeral directing or embalming; or allowing or permitting
- 12 a capper, steerer, or solicitor to obtain funeral directing or
- 13 embalming for a licensed person or funeral establishment.
- 14 (c) The direct or indirect payment or offer of payment of a
- 15 commission by a licensed person or an agent, representative,
- 16 assistant, or employee of the licensed person for the purpose of
- 17 securing business.
- 18 (d) Aiding or abetting an unlicensed person to engage in the
- 19 practice of funeral directing or embalming.
- 20 (e) Using profane, indecent, or obscene language in the
- 21 presence of a dead human body, or within the immediate hearing of
- 22 the family or relatives of a deceased, whose body has not yet been
- 23 interred or otherwise disposed of.
- 24 (f) Solicitation or acceptance by a licensed person of a
- 25 commission or bonus or rebate in consideration of recommending or
- 26 causing a dead human body to be disposed of in a crematory,
- 27 mausoleum, or cemetery.

- 1 (g) Using a casket or part of a casket which has been
- 2 previously used as a receptacle for, or in connection with, the
- 3 burial or other disposition of a dead human body.
- 4 (h) A violation of a state law or municipal or county
- 5 ordinance or regulation affecting the handling, custody, care or
- 6 transportation of a dead human body.
- 7 (i) Refusing to promptly surrender the custody of a dead human
- 8 body, upon the express order of the person lawfully entitled to the
- 9 custody.
- 10 (j) Failure to secure a permit for removal or burial of a dead
- 11 human body before interment or disposal.
- 12 (k) Obtaining possession or embalming a dead human body
- 13 without first being expressly directed or authorized to do so by a
- 14 relative of the deceased person or a person entitled to custody.
- 15 (l) Knowingly making a false statement on a certificate of
- 16 death.
- 17 (m) Removing or embalming a dead human body if there is
- 18 information indicating crime or violence in connection with the
- 19 cause of death, unless permission of the county medical examiner
- 20 has first been obtained.
- 21 (n) If a public officer or employee, an official of a public
- 22 institution, convalescent home, private nursing home, maternity
- 23 home, public or private hospital, physician or surgeon, or any
- 24 other person having a professional relationship with a decedent or
- 25 county medical examiner or other public official having temporary
- 26 custody of the decedent, sending or causing to be sent to a person
- 27 or establishment licensed under this article the remains of a

- 1 deceased person without having first made inquiry as to the desires
- 2 of the -next of kin- PERSON WITH AUTHORITY OVER THE DISPOSAL OF THE
- 3 REMAINS OF THE DECEDENT UNDER SECTION 3206 OF THE ESTATES AND
- 4 PROTECTED INDIVIDUALS CODE, 1998 PA 386, MCL 700.3206, and of the
- 5 person who may be chargeable with the funeral expenses of the
- 6 decedent. If -kin- A PERSON WITH AUTHORITY OVER THE DISPOSAL OF THE
- 7 REMAINS OF THE DECEDENT UNDER SECTION 3206 OF THE ESTATES AND
- 8 PROTECTED INDIVIDUALS CODE, 1998 PA 386, MCL 700.3206, is found,
- 9 the person's authority and directions shall govern the disposal of

- 11 (o) If a licensee, receiving remains in violation of the
- 12 requirements of subdivision (n) and making a charge for a service
- 13 in connection with the remains before the delivery of the remains
- 14 as stipulated by the -kin- PERSON WITH AUTHORITY OVER THE DISPOSAL
- 15 OF THE REMAINS OF THE DECEDENT UNDER SECTION 3206 OF THE ESTATES
- 16 AND PROTECTED INDIVIDUALS CODE, 1998 PA 386, MCL 700.3206. This
- 17 subdivision shall not prevent a person or establishment licensed
- 18 under this article from charging and being reimbursed for services
- 19 rendered in connection with the removal of the remains of a
- 20 deceased person in case of accidental or violent death, and
- 21 rendering necessary services required until the -next of kin
- 22 PERSON WITH AUTHORITY OVER THE DISPOSAL OF THE REMAINS OF THE

- 24 INDIVIDUALS CODE, 1998 PA 386, MCL 700.3206, or the person who is
- 25 chargeable with the funeral expenses is notified.
- 26 (p) If a funeral establishment or a licensee, entering upon an
- 27 agreement, directly or indirectly, in which the practice of

- 2 for the funeral establishment, licensed person or an agent,
- 3 assistant, or representative of the establishment or licensed

- 6 authority of [an administrator or executor A PERSONAL REPRESENTATIVE], trustee, or other person
- 7 having WHO HAS a fiduciary relationship with the deceased.
- **8** (q) Failure to comply with part 138 of the public health code,
- 9 Act No. 368 of the Public Acts of 1978, being sections 333.13801 to
- 10 333.13819 of the Michigan Compiled Laws 1978 PA 368, MCL 333.13801
- 11 TO 333.13831.
- 12 (2) The department, in consultation with the director of
- 13 public health, shall promulgate rules to prescribe training
- 14 standards for licensees and nonlicensees who handle medical waste
- 15 in a funeral establishment.
- 16 (3) A licensee who owns or operates a funeral establishment
- 17 shall train his or her employees pursuant to the rules promulgated
- 18 under subsection (2).
