SUBSTITUTE FOR HOUSE BILL NO. 6165

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding section 30313b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 30313B. (1) THE DEPARTMENT MAY MAKE MINOR REVISIONS IN A
- 2 PERMIT OR AN AUTHORIZATION UNDER A GENERAL PERMIT ISSUED UNDER THIS
- 3 PART IF ALL OF THE FOLLOWING APPLY:
- 4 (A) THE PROJECT IS IN COMPLIANCE WITH THE PERMIT OR
- 5 AUTHORIZATION AND THIS PART.
- 6 (B) THE MINOR REVISIONS ARE REQUESTED BY THE PERMITTEE IN
- 7 WRITING.
- 8 (C) THE REQUEST IS ACCOMPANIED BY A FEE OF \$250.00.

- 1 (D) IF THE REQUEST IS FOR A TRANSFER OF THE PERMIT OR
- 2 AUTHORIZATION, THE REQUEST IS ACCOMPANIED BY A WRITTEN AGREEMENT
- 3 BETWEEN THE CURRENT AND NEW OWNERS OR OPERATORS CONTAINING A
- 4 SPECIFIC DATE FOR TRANSFER OF RESPONSIBILITY, COVERAGE, AND
- 5 LIABILITY UNDER THE PERMIT OR AUTHORIZATION.
- 6 (2) THE DEPARTMENT SHALL APPROVE OR DENY THE REQUEST WITHIN 20
- 7 BUSINESS DAYS. HOWEVER, IF THE ONLY MINOR REVISION REQUESTED IS A
- TRANSFER AS DESCRIBED IN SUBSECTION (4)(A), THE DEPARTMENT SHALL 8
- 9 APPROVE OR DENY THE REQUEST WITHIN 10 BUSINESS DAYS. IF THE
- 10 DEPARTMENT FAILS TO APPROVE OR DENY THE REQUEST WITHIN THE TIME
- 11 REQUIRED BY THIS SUBSECTION, THE DEPARTMENT SHALL REFUND THE FEE.
- 12 (3) IF THE DEPARTMENT DETERMINES THAT NONE OF THE CHANGES
- 13 REQUESTED ARE MINOR REVISIONS, THE DEPARTMENT SHALL RETAIN THE FEE
- BUT THE PERMITTEE MAY APPLY THE FEE TOWARD A NEW PERMIT FOR A 14
- 15 PROJECT AT THAT SITE.
- 16 (4) AS USED IN THIS SECTION, "MINOR REVISION" MEANS EITHER OF
- 17 THE FOLLOWING:
- 18 (A) A TRANSFER OF AN INDIVIDUAL PERMIT OR AN AUTHORIZATION
- 19 UNDER A GENERAL PERMIT.
- 20 (B) A REVISION THAT DOES NOT INCREASE THE OVERALL IMPACT OF A
- 21 PROJECT ON WETLANDS AND THAT IS WITHIN THE SCOPE OF THE PROJECT AS
- 22 DESCRIBED IN THE ORIGINAL PERMIT OR AUTHORIZATION.
