A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding section 30313b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 30313B. (1) THE DEPARTMENT MAY MAKE MINOR REVISIONS IN A
- 2 PERMIT ISSUED UNDER THIS PART IF ALL OF THE FOLLOWING APPLY:
- 3 (A) THE PROJECT IS IN COMPLIANCE WITH THE PERMIT AND THIS
- 4 PART.
- 5 (B) THE MINOR REVISIONS ARE REQUESTED BY THE PERMITTEE IN
- 6 WRITING.
- 7 (C) THE REQUEST IS ACCOMPANIED BY A FEE OF \$250.00.
- 8 (D) IF THE REQUEST IS FOR A TRANSFER OF THE PERMIT, THE

- REQUEST IS ACCOMPANIED BY A WRITTEN AGREEMENT BETWEEN THE CURRENT 1
- 2 AND NEW OWNERS OR OPERATORS CONTAINING A SPECIFIC DATE FOR TRANSFER
- 3 OF RESPONSIBILITY, COVERAGE, AND LIABILITY UNDER THE PERMIT.
- 4 (2) THE DEPARTMENT SHALL APPROVE OR DENY THE REQUEST WITHIN 20
- BUSINESS DAYS. HOWEVER, IF THE ONLY MINOR REVISION REQUESTED IS A 5
- 6 TRANSFER UNDER SUBSECTION (4)(A), THE DEPARTMENT SHALL APPROVE OR
- 7 DENY THE REQUEST WITHIN 10 BUSINESS DAYS. IF THE DEPARTMENT FAILS
- TO APPROVE OR DENY THE REQUEST WITHIN THE TIME REQUIRED BY THIS 8
- SUBSECTION, THE DEPARTMENT SHALL REFUND THE FEE.
- (3) IF THE DEPARTMENT DETERMINES THAT NONE OF THE CHANGES 10
- 11 REQUESTED ARE MINOR REVISIONS, THE DEPARTMENT SHALL RETAIN THE FEE
- 12 BUT THE PERMITTEE MAY APPLY THE FEE TOWARD A NEW PERMIT FOR A
- PROJECT AT THAT SITE. 13
- 14 (4) AS USED IN THIS SECTION, "MINOR REVISION" MEANS EITHER OF
- THE FOLLOWING WITH RESPECT TO A PERMIT ISSUED UNDER THIS PART: 15

- (B) A REVISION THAT DOES NOT INCREASE THE OVERALL IMPACT OF A 17
- 18 PROJECT ON WETLANDS AND THAT IS WITHIN THE SCOPE OF THE PROJECT AS
- 19 DESCRIBED IN THE ORIGINAL PERMIT.
