## **HOUSE BILL No. 4609**

April 14, 2005, Introduced by Reps. Whitmer, Condino, Farrah, Zelenko, Miller, Byrnes, Bieda, Kathleen Law, Meisner, Brown, Gillard, Murphy, Kolb and Cushingberry and referred to the Committee on Employment Relations, Training, and Safety.

A bill to amend 1976 PA 453, entitled "Elliott-Larsen civil rights act,"

by amending sections 102, 103, and 202 (MCL 37.2102, 37.2103, and 37.2202), section 102 as amended by 1992 PA 124, section 103 as amended by 1999 PA 202, and section 202 as amended by 1991 PA 11.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 102. (1) The opportunity to obtain employment, housing and other real estate, and the full and equal utilization of public accommodations, public service, and educational facilities without discrimination because of religion, race, color, national origin, age, sex, height, weight, familial status, or marital status as prohibited by this act — is recognized and declared to be a civil
