- 22 (B) "MANDATED HEALTH BENEFIT" MEANS A PARTICULAR HEALTH CARE
- 23 SERVICE, BENEFIT, COVERAGE, OR REIMBURSEMENT FOR COVERED HEALTH
- 24 CARE SERVICES THAT A HEALTH CARE CORPORATION IS REQUIRED BY STATUTE
- 25 TO PROVIDE OR OFFER IN A CERTIFICATE THAT IS ISSUED, RENEWED, OR
- 26 DELIVERED IN THIS STATE.
