- 25 BY, MANURE OR ANY OF THE COMPONENTS LISTED IN THE DEFINITION OF
- 26 PRODUCTION AREA. PRODUCTION AREA WASTE DOES NOT INCLUDE WATER FROM
- 27 LAND APPLICATION AREAS.
