## SENATE SUBSTITUTE FOR HOUSE BILL NO. 5289

A bill to amend 1987 PA 173, entitled "Mortgage brokers, lenders, and servicers licensing act," (MCL 445.1651 to 445.1684) by adding section 2c.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 2C. (1) A LOAN OFFICER REGISTRANT SHALL PROVIDE WRITTEN
- 2 NOTICE TO THE COMMISSIONER WITHIN 10 DAYS AFTER ANY OF THE
- 3 FOLLOWING OCCUR:
- 4 (A) HIS OR HER EMPLOYMENT OR AGENCY RELATIONSHIP WITH A
- 5 LICENSEE OR REGISTRANT IS TERMINATED.
- 6 (B) HE OR SHE BEGINS EMPLOYMENT OR AN AGENCY RELATIONSHIP WITH
- 7 A LICENSEE OR REGISTRANT.
- 8 (C) THERE IS A CHANGE IN THE HOME ADDRESS OR ANY PERSONAL
- 9 TELEPHONE NUMBER OR PERSONAL ELECTRONIC MAIL ADDRESS HE OR SHE

- 1 PREVIOUSLY PROVIDED TO THE COMMISSIONER.
- 2 (D) HE OR SHE IS CONVICTED OF OR PLEADS GUILTY OR NO CONTEST
- 3 TO ANY OF THE FOLLOWING:
- 4 (i) A MISDEMEANOR INVOLVING EMBEZZLEMENT, FORGERY, FRAUD, A
- 5 FINANCIAL TRANSACTION, OR SECURITIES.
- (ii) A FELONY.
- 7 (2) A LICENSEE OR REGISTRANT SHALL PROVIDE WRITTEN NOTICE TO
- 8 THE COMMISSIONER WITHIN 20 DAYS AFTER HIRING OR ENGAGING AN
- 9 INDIVIDUAL AS A LOAN OFFICER OR TERMINATING THE EMPLOYMENT OF OR
- 10 AGENCY RELATIONSHIP WITH A LOAN OFFICER.
