A bill to amend 1956 PA 218, entitled
"The insurance code of 1956,"

(MCL 500.100 to 500.8302) by adding section 3406s.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 3406S. (1) AN EXPENSE-INCURRED HOSPITAL, MEDICAL, OR
- 2 SURGICAL POLICY OR CERTIFICATE DELIVERED, ISSUED FOR DELIVERY, OR
- 3 RENEWED IN THIS STATE AND A HEALTH MAINTENANCE ORGANIZATION GROUP
- 4 OR INDIVIDUAL CONTRACT SHALL INCLUDE COVERAGE FOR PROSTHETICS AND
- 5 ORTHOTICS THAT, AT A MINIMUM, EQUALS THE PROSTHETICS AND ORTHOTICS
- 6 COVERAGE PROVIDED FOR UNDER 42 USC 1395K, 1395l, AND 1395N AND 42
- 7 CFR 410.100, 414.202, 414.210, AND 414.228. COVERAGE SHALL INCLUDE
- 8 REPLACEMENT FOR THE PROSTHETIC OR ORTHOTIC IF REQUIRED BECAUSE OF A
- CHANGE IN THE MEMBER'S PHYSICAL CONDITION AND FOR REPAIR OR

- 1 PHYSICIAN. COVERAGE MAY BE LIMITED TO THE MOST APPROPRIATE MODEL

- 22 (A) "ORTHOTICS" MEANS ALL SERVICES REQUIRING CUSTOM ORTHOSES.
- 23 (B) "PROSTHETICS" MEANS EXTERNAL EXTREMITY PROSTHETICS FOR THE
- 24 APPENDICULAR SKELETON.
- 25 Enacting section 1. This amendatory act takes effect 180 days
- 26 after the date it is enacted.
