- 6 (C) THERE IS A CHANGE IN THE HOME ADDRESS OR ANY PERSONAL
 7 TELEPHONE NUMBER OR PERSONAL ELECTRONIC MAIL ADDRESS HE OR SHE
 8 PREVIOUSLY PROVIDED TO THE COMMISSIONER.
