HOUSE BILL No. 5432

November 8, 2007, Introduced by Reps. Clemente, LeBlanc, Opsommer, Spade, Polidori, Espinoza, Griffin and Robert Jones and referred to the Committee on Military and Veterans Affairs and Homeland Security.

A bill to amend 1998 PA 541, entitled "Corrections officer's survivor tuition act," by amending section 4 (MCL 390.1264).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 4. (1) Beginning in the 1998-1999 academic year, upon receiving an application under section 3(c), the department shall determine whether the applicant and the courses for which tuition waiver is sought meet the requirements of section 3 and, if so, shall approve the application and notify the state institution of higher education that the application has been approved.
 - (2) Beginning SUBJECT TO SUBSECTION (3), BEGINNING in the 1998-1999 academic year, upon application by the state institution of higher education, the department annually shall reimburse each

- 14 WHILE THAT ACTIVE DUTY MEMBER IS STATIONED IN THIS STATE AND DURING
- 15 THE STUDENT'S CONTINUOUS ENROLLMENT IN THE ACADEMIC DEGREE PROGRAM
- 16 IN WHICH HE OR SHE IS ENROLLED IF THAT ACTIVE DUTY MEMBER IS
- 17 TRANSFERRED TO ACTIVE DUTY OUTSIDE OF THIS STATE.
- 18 (B) A CHILD OF AN ACTIVE DUTY MEMBER OF THE ARMED FORCES OF
- 19 THE UNITED STATES WHO WAS STATIONED IN THIS STATE BUT IS
- 20 TRANSFERRED TO A DUTY LOCATION OUTSIDE OF THIS STATE WITHIN THE 1-
- 21 YEAR PERIOD PRECEDING THE STUDENT'S INITIAL ENROLLMENT IN THAT
- 22 INSTITUTION AND THE STUDENT CONTINUES TO LIVE IN THIS STATE.
