- 3 WITH APPLICABLE BUILDING CODES OF A UNIT OF LOCAL GOVERNMENT IN
 - WHICH THE FACILITY IS LOCATED.
- 5 (2) A UNIT OF LOCAL GOVERNMENT MAY, AS ALLOWED BY ORDINANCE,
- 6 ISSUE AN ORDER TO THIS STATE TO, AT THE EXPENSE OF THIS STATE,
- 7 CORRECT OR REMOVE A FACILITY OR CONDITION OF A FACILITY THAT
- 8 VIOLATES A BUILDING CODE APPLICABLE TO THE FACILITY UNDER
