My name is Douglas Phillips Jr. and I am currently a prisoner at the Mid-Michigan Correctional Facility in St. Louis, Michigan. I have served 12 years of a 15 to 30 yr sentence for "assault with intent to murder", with 23 months left before review by the parole board. Key word being review. I took responsibility after committing the crime for which I am now currently incarcerated for by turning myself into the proper authorities to face my accusers and accept the penalty and punishment for my wrongdoing. I displayed remorse to those I harmed and their families, as well as my own. Learning that based on my actions our families and community was also harmed. From that day on I decided to be part of the solution and not that of the problem. In 2005 I became a facilitator of the pilot program of the Michigan Prisoner Re-entry initiative program. After meeting with a representative of Gov. Granholm's office and deputy Warden Carrberry at the Macomb Correctional Facility in which I was informed along with 9 other prisoners of the following trainers facilitator courses in which we all would be become educated. Anger Management, Cage your Rage, Conflict Resolution, Parenting, Time Management, Multicultural awareness, Cognitive thinking,, Budgeting and Financing. the ten of us experienced success as facilitators in facilitating other prisoners, proving the program could and would work in Michigan. Sadly to say after much funding into the MPRI program, myself and the other 9 prisoners were not allowed to facilitate anymore due to the hiring of retired corrections officers. Educated and still motivated i went on to teach and facilitate the alcohol, drug and substance abuse program for prisoners in which this was a RGC recommendations requirement for their paroles. To the members of the Michigan Legislature, the prosecutors representing the victims, and the victims family members, apologies, empathy and sympathy is in order, but I'm also asking something of you as well, and that its a chance to be forgiven and redeemed for accepting my fate and punishment, for the crime and only crime in which I committing and assumed responsibility for so doing. The facts on passing HB4497, 4498, 4499 does not automatically mean that a mass amount of prisoners will be released. The facts are that prisoners must meet a set of criteria. They must be misconduct free, for and during the good time credit review. Key word review. This review would be by the prison unit officers, in which the prisoner are housed and under the direct supervision with the final approval of the unit staff, Arus/ Counselor and the Warden of that said Correctional facility in which the prisoner is currently a resident. The second step is for the parole board review. Key word being review, In which the parole board members would review to see if the prisoner has met the required set of recommendations as set forth by the Receipting Guidance Center upon the prisoners entry into the Michigan Department of Corrections for which he or she must meet before release. which would include a psychological evaluation and the parole board having the final say. Simply put, the passing of HB 4497,4498,4499 will allow certain prisoners that meet all said above criteria to be placed in the jurisdiction of the parole board in which the parole board today follows its same review, rules as it would if these bill are to passed. Key word being review, as everything is reviewed.

My plea is that the length of the sentences be fitting based on behavior displayed during the rehabilitation, and not exclusively to initial sentences.

Sec. 33 of House Bill 4497 stands to emancipate those inmates contingent on their full, complete, indisputable rehabilitation, saying "The prisoners' mental and social attitude, the facts and circumstances behind their incarceration, and the knowledge that the prisoner will not be a menace to society".

My family and I support the bill, and hope that it will help to decrease the number of inmates and increase the number of capable and positive contributors to the crumbling social structure we're faced with today. For the daughters and sons who have truly learned their parents' lessons behind bars, we ask for total support of 4497.
