- 1 SEC. 3407C. (1) A QUALIFIED HEALTH PLAN OFFERED THROUGH A
- 2 STATE EXCHANGE PURSUANT TO THE PATIENT PROTECTION AND AFFORDABLE
- 3 CARE ACT, PUBLIC LAW 111-148, SHALL NOT PROVIDE COVERAGE FOR
- 4 ELECTIVE ABORTION. NOTHING IN THIS SECTION SHALL BE CONSTRUED TO
- 5 PROHIBIT AN INDIVIDUAL, ORGANIZATION, OR EMPLOYER PARTICIPATING IN
- 5 A QUALIFIED HEALTH PLAN OFFERED THROUGH A STATE EXCHANGE FROM
- 7 PURCHASING OPTIONAL SUPPLEMENTAL COVERAGE FOR ELECTIVE ABORTION

- 1 WOMAN'S PREGNANCY FOR A PURPOSE OTHER THAN TO INCREASE THE
